MINUTES MENDOTA PUBLIC SAFETY SUB-COMMITTEE **MEETING** January 4, 2021 12:00 NOON Mendota City Hall

I. CALL TO ORDER

The meeting was called to order by Vice-Chairperson Rosales at 12:01 p.m.

II. ADOPTION OF MINUTES

The minutes for the meeting of November 2, 2020 were approved based on a motion made and seconded, and unanimous approval.

III. BUSINESS

1. Vice-Chairperson Rosales

Vice-Chairperson Rosales thanked staff and Mr. Amador for their work and stated that he would like to hold monthly Public Safety Sub-Committee meetings.

 - a) Traffic enforcement

Committee Member Amador introduced the item and inquired about potential projects to improve the safety of roadways in the community and reported on a fatal accident that recently occurred.

John Liu with Caltrans provided an update on the proposed roundabout at the intersection at Oller Street and Derrick Avenue; and reported on proposed improvements of Oller Street to mitigate the traffic concerns at the intersection of 7th Street and Oller Street.

c) Discussion on body cameras for police officers

Committee Member Amador introduced the item.

Discussion was held on the costs associated with purchasing and maintaining body cameras for police officers; and a fatal accident that recently occurred.

Committee Member Amador thanked the Police Department for attending the Toy Giveaway event at Mendota Smog.

Vice-Chairperson Rosales inquired as to whether additional lighting can be installed near the intersection of Highway 33 and Bass Avenue.

Chief of Police Smith provided an update on the Code Enforcement department, including the status of the replacement Animal Control truck.

Chief Smith provided an update on the Police Department including vandalism cases; the launch of the motorcycle units; and provided a report on the New Year's Eve police detail.
