BUSINESS

1. Commission discussion on the facility use application process.

Chairperson Mendoza introduced the item, reported on the actions that the Commission has taken in the past regarding facility use applications, and inquired about the facility use application process.

Discussion was held on the condition of the recreation fields; the actions that the Commission has taken in the past regarding facility use applications; whether organizations are interested in utilizing the sport fields; whether interested organizations will be required to provide the guidelines that they will follow to prevent the spread of COVID-19; ensuring that organizations are able to utilize both fields equally; issues that may result from the utilization of the fields, including as a result of the existence of only one concession stand; and when the new fields may be used.

2. Commission discussion on the status of the Rojas-Pierce Park Expansion project.

Chairperson Mendoza introduced the item.

Discussion was held on the completion of the first phase of the Rojas-Pierce Expansion; what the second phase of the project consists of; the status of the acquisition of additional land for the project; the total cost estimate for the entire project; the timeline for the project; when the new ball fields can be used; the lack of lighting at the new ball fieldst; and improving the Benny Mares Sr. baseball field.

3. Commission discussion on the status of fundraising opportunities for the new baseball and soccer fields at Rojas-Pierce Park.

Chairperson Mendoza introduced the item and commented on fundraising opportunities that were previously discussed.

Discussion was held on potential fundraising opportunities; the costs associated with the fundraising opportunities; the timeline for implementing the opportunities; the process of naming the new fields; honoring Mendota residents; whether organizations who utilize the fields will be able to hang their own sponsor banners; the revenue that will be generated; and upcoming vacancies on the Recreation Commission.

COMMISSIONER REPORTS AND INFORMATIONAL ITEMS

Commissioner Sanchez provided information on the Mendota Mural Project and inquired about the process for utilizing the park.

Vice-Chairperson Ochoa inquired as to whether the parks are open.

Commissioner Romero inquired about honoring Mendota residents and wished everyone well.

Chairperson Mendoza wished everyone a happy New Year.

SUBJECT: SPONSORSHIP OPPORTUNITIES

DATE: FEBRUARY 4, 2021

ISSUE

Discussion and direction to staff on potential sponsorship opportunities for the ball fields at Rojas-Pierce Park.

BACKGROUND

For the past several months, the Recreation Commission has discussed implementing various sponsorship opportunities for the new expansion of Rojas-Pierce Park. As such, staff has looked into three different opportunities for the ball fields at the park: honor wall, banners, and naming rights.

ANALYSIS

Staff looked into the details of each sponsorship opportunity including program organization, material needs, and costs associated with each option. Below is a summary of these items for each option.

Honor Wall

The concept of the honor wall derived from the Teachers and Friends of Education Honor Wall at Fresno State. For the Fresno State honor wall, donors may purchase an engraved brick for \$100 that contains the honoree's name and an optional second line of text that will be placed on the honor wall. In addition, the recipient of the honor receives notification of the gift along with a commemorative certificate and the donor receives a letter of appreciation for remembering the honoree with the gift.



Honor Wall at Fresno State

Staff contacted the Bell Memorials and Granite Works, the company that provides the engraved bricks for Fresno State, and inquired about direct costs for the bricks. Each individual brick costs \$65 and the price includes up to three lines of engraved text and brick installation. The bricks are 8"x4" and come in an array of colors. Bell Memorials stated that special pricing may be available for bulk purchases. However, Bell Memorials did state that they do not construct the actual wall where the bricks are installed. The details of the design and construction of the honor wall is an item that still needs to be discussed and decided on, but that is an item that may be completed by City staff. Moreover, the bricks can be installed in other areas, including on the new restroom/concession building.

Staff also inquired about the costs associated with purchasing engraved paver tiles with the idea of creating a donor trail (in lieu of a honor wall) and was informed that the price begins at \$125 per 12"x12" paver tile and actual price depends on what is engraved on each paver.

Staff is recommending that the Recreation Commission discuss the information provided and give direction to staff on the following:

- 1. Selection of installation location (standalone wall, side of building, or trail); and
- 2. Donation cost

Banners

Previous discussion was held by the Commission on the creation of a banner program that had two distinct sponsorship levels: (1) one 4'x8' banner and (2) one 3'x6' banner. The direct cost for each banner depends on the type of material that the banners are made out of. Based on where the banners will be located, the weather conditions that the banners will endure, and the length of time that they will be hung, staff looked into three types of banner material: vinyl, mesh, and coroplast.

Staff is recommending that the Recreation Commission discuss the information provided and give direction to staff on the following:

- 1. Selection of banner material; and
- 2. Donation cost

Naming Rights

The Commission has also discussed the naming rights for the new baseball and soccer field as a potential sponsorship opportunity. However, discussions have also been held on the possibility of honoring Mendota natives by naming the fields after them instead of offering the naming rights as a sponsorship opportunity. If that is the desire of the Commission and the City Council, another option can be offering the naming rights of the entire facility as a sponsorship opportunity. For example, the entire facility that includes all three ballfields can form the "[SPONSOR NAME] Sports Complex" or the "Mendota Sports Complex presented by [SPONSOR NAME]". The selected sponsor's name will be displayed on a sign at the facility's entrance.

Those interested in acquiring the naming rights for the facility can submit bids with the naming rights being awarded to the highest bidder, or a sponsorship price can be established, and the naming rights will be awarded on a first come, first serve basis.

Staff is recommending that the Recreation Commission discuss the information provided and give direction to staff on the following:

- 1. Confirmation of facility naming rights as a sponsorship opportunity; and
- 2. Sponsor selection process

FISCAL IMPACT

None at this time.

RECOMMENDATION

Staff recommends that the Commission discuss the information provided and give direction to staff on the items outlined above.
