SUBJECT: SPONSORSHIP OPPORTUNITIES

ISSUE

Discussion and direction to staff on potential sponsorship opportunities for the ball fields at Rojas-Pierce Park.

BACKGROUND

For the past several months, the Recreation Commission has discussed implementing various sponsorship opportunities for the new expansion of Rojas-Pierce Park.
