FINALIZE THE AGENDA

A motion was made by Councilor Rosales to adopt the agenda, seconded by Councilor Mendoza; unanimously approved (4 ayes).

PRESENTATION

1. Council to honor Robert Silva for his service.

At 6:07 p.m. all Council Members stepped down from the dais to thank and to present Mr. Robert Silva with a plaque of recognition for his service to the City of Mendota.

Mayor Castro thanked Mr. Silva for all of his efforts and for his guidance.

Councilor Mendoza thanked Mr. Silva for all of his work, efforts, and for the opportunity he gave to him to serve on the City Council.

A motion was made by Mayor Pro Tem Martinez to approve items 1 and 2, seconded by Councilor Rosales; unanimously approved (4 ayes).

2. Council discussion and consideration of **Resolution No. 20-03**, approving a Request for Proposals for Back Flow Services

Mayor Castro introduced the item and Finance Officer Diaz provided report including the city's Backflow Prevention Program.

Discussion was held on the costs of the backflow testing; the possibility of training a staff member to conduct the backflow testing and the preference of having a third party conduct the backflow test; and the liability of the service.

Joseph Riofrio commented on his experience with backflow testing service provider.

A motion was made by Councilor Rosales to approve Resolution No. 20-03, seconded by Mayor Pro Tem Martinez; unanimously approved (4 ayes).
