SUBJECT: FACILITY USE FEES FOR BASEBALL AND SOCCER FIELDS

**DATE:** MAY 6, 2021

#### **ISSUE**

Discussion and consideration of increasing the facility use fees for the baseball fields and establishing a facility use fee for the soccer field.

#### BACKGROUND

At its April 1<sup>st</sup> regular meeting, the Commission discussed the possibility of increasing the fees charged for the use of the baseball field and directed staff to survey surrounding cities for their facility use fees. Additionally, the City recently constructed a new soccer field and given that there are no established fees, it is necessary for the Commission to consider implementing facility use fees for the soccer field.

#### ANALYSIS

Staff reached out to the cities of Firebaugh, Kerman, and San Joaquin and the cities of Firebaugh and Kerman provided staff with a list of the fees charged for soccer and baseball fields (San Joaquin did not respond to our request). A breakdown of the fees charged are listed below:

#### **Priority Group Classifications**

Priority use of fields will be allocated as follows:

**Group 1:** City sponsored or co-sponsored events. City youth/adult athletic programs and/or leagues. Kerman Unified School District schools have priority at school sites prior to 6 pm on weekdays when school is in session (per our JUA)

**Group 2:** Non-profit or not-for-profit youth organizations (i.e. KGSL, Kerman Cal Ripken, KYSL, and KYF). Must have at least 90% residents and/or minimum of 200 Kerman resident participants. Conduct open registration regardless of skill level. Maintain a national/state affiliation. Follow National Alliance of Youth Sports (NAYS) or equivalent program as defined by the Department. Operate through volunteer coaches and administrators. Provide an "everyone plays" philosophy.

**Group 3:** Youth organizations (i.e. Travel Teams) or private events with 51%-90% Kerman residency and/or less than 200 Kerman resident participants.

**Group 4:** Youth organizations (i.e. Travel Teams) or private events with under 51% Kerman residency and/or less than 200 Kerman resident participants.

**Group 5:** General youth and adult users. For profit organizations, tournaments, clinics and/or camps with individual or team participation fees.

#### **ISSUE**

Shall the Commission discuss and consider the potential sponsorship opportunities for the ball fields at Rojas-Pierce Park, and adopt Resolution No. RC 21-01, forwarding a recommendation to the City Council to establish sponsorship opportunities for Rojas-Pierce Park?

#### BACKGROUND

For the past several months, the Recreation Commission has discussed implementing various sponsorship opportunities for the new ball fields at Rojas-Pierce Park.

#### ANALYSIS

Staff reached out to several companies to acquire quotes for the materials associated with each sponsorship opportunity so that the Commission can establish the cost for each item. While staff received the quotes for the banners and the honor wall tiles, we are still waiting on receiving the necessary information for the sports complex sign and the scoreboards. As such, the Board will only be considering finalizing the details of the banners and honor wall tiles at this meeting.

Below is breakdown of the material costs associated with the banners and honor wall tiles and the action that the Commission needs to take for each item.

#### **Banners**

Staff received quotes from four (4) companies for single-sided 3'x6' and 4'x8' vinyl banners for outdoor use with grommets. The quotes were as follows:

All quotes do not include taxes or shipping costs.

Given that A1 Signs and Banners provided the lowest, responsive quote, staff recommends that the banners be purchased from them and that the Commission determine the sponsorship amount for each banner size.


