ISSUE

Shall the City Council adopt Resolution No. 21-70, supporting the timely use of funding in the matter of project delivery schedules for Federal Transportation project selection?

BACKGROUND

Approval of AB 1012 requires that both State and Federal funds be used in a "timely" manner. In order to avoid losing any Federal or State funds to our Region, the "use it or lose it" requirements of AB 1012 place local governmental agencies in a position that they must be able to deliver their projects on time. That is, they must be able to meet their project delivery schedules as proposed and as programmed within the Federal Transportation Improvement Program ("FTIP").

Because the issue of "project delivery is so important, each agency must be able to assure that their project(s) can be delivered timely. Therefore, each application for Congestion Mitigation and Air Quality ("CMAQ") or Surface Transportation Block Grant ("STBG") funding must be accompanied by a formal Council Resolution stating that each project will meet project delivery schedules and that staff be directed to ensure that projects are delivered timely.

Lifeline and regional bid projects must be delivered in the programmed year specified and within the programming years of the FTIP (covering federal fiscal years 2022/23, 2023/24, 2024/25, and 2025/26). If a regional bid project is delayed due to unforeseen circumstances, projects, at any phase, may be pushed out. If the project is delayed more than two FTIP cycles, the project will be programmed based on financial capacity and at Fresno Council of Governments' ("FCOG's") discretion.

ANALYSIS

The City Engineer and staff intend on submitting applications during the 2021 Call for Projects for the regional bid (competitive) for the following projects:

- CMAQ Derrick & Oller Roundabout
- STBG Reconstruction of 5th Street from Quince to Derrick/SR 33

FISCAL IMPACT

There is no fiscal impact for the preparation of the CMAQ and STBG applications requesting funding for the listed projects. Should the projects be awarded funding, City's street funds - Gas Tax, LTF, Measure C and/or RMRA (SB1) funds - will be utilized for preliminary engineering, right-of-way clearance, construction management and the standard 11.47% local match of federal funds.

RECOMMENDATION

Staff recommends that the City Council adopt Resolution No. 21-70, supporting the timely use of funding in the matter of project delivery schedules for Federal Transportation project selection.

ISSUE

Shall the City Council adopt Resolution No. 21-71, awarding a construction contract to the lowest responsive, responsible bidder Avison Construction, Inc. for the 2021 Alley Paving Project?

BACKGROUND

The City has been awarded \$458,304 in Congestion Mitigation and Air Quality (CMAQ) funding for the construction of the 2021 Alley Paving Project to pave Alleys 4L, 5L, 7L, and 7U which are currently unpaved; some small segments of alleys with poor pavement condition that are withing the unpaved alley sections will also be repaved and the paved Alley 7U1 will also be repaved.

Provost & Pritchard Consulting Group was retained to provide land surveying and engineering design services for the Project and they have prepared plans and specifications for bidding and construction of the project and obtained environmental clearances (CEQA & NEPA.)

On August 9, 2021 the City received authorization from Caltrans for funding for the construction of the project.

The request for bids was advertised in the Business Journal and construction documents (plans and specifications) have been available to contractors through local Builder's Exchanges since Friday, August 13, 2021.

On Friday, September 3, 2021 at 2:00 p.m. the public bid opening was held. Five general contractors attended and submitted bids, along with staff and the City Engineer. The bids were as follows:

ANALYSIS

We have reviewed the submitted bid packages. The apparent lowest bidder is Seal Rite Paving; however, upon review of their bid documents, errors and omissions were found that deem their bid proposal as non-responsive. The next lowest bidder's proposal is from Avison Construction, Inc. and was reviewed and found to be complete, responsive and meeting the Disadvantaged Business Enterprise (DBE) goal of the project. The Engineer's Opinion of Probable Construction Cost for the Project Total Base Bid was \$520,000. The received bids are around this estimated amount, with four of the five being lower. Avison Construction's bid price is within the allocated project funding and represents a good value to the City.

This project is scheduled to start later this month and be completed in November. This schedule meets the obligated authorization date for the funding (FFY 20/21) and minimizes the potential for weather delays from rain and relatively low daytime temperatures (highs around 55 degrees) that typically occur starting in late November.

Provost & Pritchard Consulting Group will be retained to provide construction administration, staking and observation services (time and material budget of \$45,000.)

FISCAL IMPACT

The City has been allocated \$458,304 in CMAQ funding for construction of the portion of the project that is paving currently unpaved alleys and the City's CMAQ Lifeline funds will be used to meet the required 11.47% local match. The City will pay approximately \$109,000 from local Street Funds (Gas Tax, Measure C and Local Transportation Funds) to pay for the reconstruction of segments of paved alleys within or adjacent to the alleys included in the project and the construction administration, staking and observation. Use of these funds were included in the approved Fiscal Year 2021/2022 Budget. This project will not impact the General Fund.

RECOMMENDATION

Staff recommends that the City Council adopt Resolution No. 21-71, awarding the contract for construction of the Project to the lowest responsible, responsive bidder, Avison Construction, Inc., in the total of \$430,441.00, retaining Provost & Pritchard Consulting Group for professional construction phase services, and authorizing the City Manager or his designee to execute all documents necessary for the completion of the Project.

WHEREAS, Avison Construction, Inc. has performed responsibly on past projects for the City; and

WHEREAS, the sum of the base bid from Avison Construction, Inc. is within the Project's construction budget; and

WHEREAS, Provost & Pritchard Consulting Group submitted a contract amendment to provide construction administration for the Project, staking, and observation services for a time and materials budget of \$45,000; and

ISSUE

Staff is requesting input from the City Council to assist in defining a vision and goals for the Local Road Safety Plan.

BACKGROUND

Fresno Council of Governments (FCOG) has contracted with Kittelson and Associates (Kittelson) to prepare a Multijurisdictional Local Road Safety Plan (MLRSP) for several agencies in Fresno County, including the City of Mendota. This plan will be a prerequisite to applying to Caltrans for Highway Safety Improvement Plan (HSIP) funding. As part of the process to create the MLRSP, Kittelson has met with the City Engineer and staff, reviewed road and traffic accident data for the City of Mendota, and prepared recommended countermeasures and HSIP strategies.

The following is taken from the Local Existing Conditions reports prepared as part of the Kittleson's efforts.

The City of Mendota has an approximate population of 12,280. The average daily vehicle miles traveled is 32,142, and the City maintains approximately 27 total roadway centerline miles. The main roadways in the City include Derrick Avenue and Oller Street from North to South and Belmont Avenue and Bass Avenue from East to West. Kittelson worked with FCOG to assemble collision data for the City of Mendota using the Statewide Integrated Traffic Records System (SWITRS) database, supplemented with location information from the Transportation Injury Mapping System (TIMS) database maintained by SafeTREC at the University of California, Berkeley.

The collision database represents the time period of January 1, 2015 through December 31, 2019. Within the assembled regional collision database, there are a total of 348 reported collisions in Mendota. Collision severity is coded according to the highest degree of injury exhibited, and the data used for this analysis includes the following coded severity levels (listed in descending order):

- *Fatal*: death from injuries sustained in the collision
- *Severe Injury*: Injuries include, for example, broken bones, severe lacerations, or other injuries that go beyond the reporting officer's assessment of "other visible injuries."

- *Other visible injury*: An injury, other than those described above, that is evident to observers at the scene of the collision—for example, bruises or minor lacerations.
- *Complaint of pain*: Internal or other non-visible injuries—for example, a person limps or seems incoherent
- Property damage only (PDO): No injuries sustained

For simplicity in presentation, Kittelson combined collisions "other visible injury" and "complaint of pain" collisions into a single "other injury" category.

ISSUE

Should the City Council adopt Resolution No. 21-68, authorizing the placement of special assessments on the 2022-2023 tax roll for 2021 nuisance abatement costs?

BACKGROUND

City of Mendota Code Enforcement has performed abatements on properties within the City with weeds on them constituting a public nuisance. A total of two (2) properties were forcibly abated.

Following a first "initial" notice and a second "courtesy" notice, properties were checked for compliance, and if they still failed were informed that if they did not comply, the City would proceed with a forced abatement. While some property owners abated the nuisance on their own, those that did not do so were forcefully abated by a private contractor hired by the City.

ANALYSIS

The attached resolution includes the cost that will be assessed to each parcel to recover City costs incurred through abatement proceedings. The Cost Report and Summary attached to the resolution was submitted and filed with the City Clerk. All detected properties were abated before the 4th of July holiday in order to decrease the risk of a destructive fire on those properties. This is what is being considered by Council to be added to the 2021 tax rolls.

In accordance with the Mendota Municipal Code, a notice of this public hearing was posted on each property and mailed to each property owner impacted. The notice of the public hearing was also posted on the kiosk outside City Hall. Letters were also mailed out to the property owners detailing the amount that is owed, notifying them that they have the ability to pay the abatement costs prior to the assessment and that they also have the right to submit a written or oral protest before or during the public hearing at this Council meeting.

Staff recommends that the City Council discuss the item, invite members of the public to comment on the matter, and consider the attached resolution for adoption. Once the City Council adopts the resolution, staff will be able to move forward with placing the abatement assessments on the 2022-2023 tax roll. Each property owner will have the corresponding amount described in the Cost Report and Summary levied on their upcoming property tax bill and will be required to remit payment.

FISCAL IMPACT

Approximately \$4,698.68 spent to abate, which will be recovered by assessing the property owners on their property tax bills.

RECOMMENDATION

Staff recommends that the City Council adopt Resolution No. 21-68, authorizing the placement of special assessments on the 2022-2023 tax roll for 2021 nuisance abatement costs.

GRANTS UPDATE

- County of Fresno, Urban Community Development Block Grant (CDBG) Program Staff contacted the County of Fresno (County) to get an update on our requested budget to include funding from 2019-2020, 2020-2021 and 2021-2022. Our allocation is \$575,222.00 for all three fiscal years. Since we are advancing our allocation for 2021-2022, we will forfeit funding for 2022-2023. The City will be able to submit an application for funding in 2023-2024. All funding will be used for the Rojas-Pierce Park Expansion Project. Staff is working on issuing an RFQ for CDBG Engineering Services, a HUD requirement that needs to be quickly.
- County of Fresno, Urban Community Development Block Grant Program for Eligible Activities to Support Coronavirus and Other Infectious Disease Response The "Mendota Internet Connectivity, Project No. 19741-CV (MIC) is open. Funds need to be disbursed by November 2021. Challenges we are facing is applicant need to be a U.S. citizen or have legal immigration status. This is a funding requirement enforced by the U.S. Department of Housing and Urban Development (HUD). We will be sending out a flyer in September's utility billing. Staff is reviewing other alternatives to expending the remaining funds since we have approximately, \$60,774.15. Other alternatives would be to allocate funding to food pantry, senior citizen meals and personal protection equipment.
- FEMA-4482-DR-CA California Covid-19 Pandemic Staff is in the process of submitting for reimbursement.
- Statewide Park Development and Community Revitalization Program (SPP) Staff submitted an application for a new community center, outdoor fitness court and inclusive playground to be located at the Rojas-Pierce Park on Friday, March 12, 2021. We are still waiting for the grant award announcements which should be late Summer 2021.
- Wonderful Community Grants The 2021-2022 grant cycle closed on August 31st. The Mendota Community Corporation applied for a \$50K to assist with (30) applications of the last round of rental relief program which was awarded this past May 2021 for \$1K each, (135) \$100 utility assistance and (100) \$65 adult dental care cleaning.
- Office of Traffic Safety: Staff will be preparing an application to apply for a grant with the Office of Traffic Safety for DUI checkpoints. This application will be partnership with other cities to host DUI checkpoints in their cities. Mendota will be the lead applicant. This application is due January 2022.

• **Small Community Drought Relief Program** – Staff will be working on a grant to submit to the Division of Water Rights for water storage.
