BACKGROUND

Due to the small size of City Clerk departments and consequent lack of resources smaller cities in Fresno County tend to have, many cities contract with the County Clerk/Registrar of Voters office to provide the needed personnel, equipment, and other resources to manage, count votes for and report the results of the local elections. This has been what the City of Mendota ("City") has done for decades.

ANALYSIS

Without the help of the County Clerk, the City would need to spend countless hours and resources to run our own local elections. The cost of the County Clerk providing election services to the City was \$2,207.32 in 2018 and \$5,899.95 in 2020.

FISCAL IMPACT

Expenditures consistent with what the City was charged in previous elections.

RECOMMENDATION

WHEREAS, it is the desire of the City Council of the City of Mendota to adopt a Resolution requesting the Board of Supervisors of the County of Fresno render specified services to the City of Mendota relating to the conduct of a General Municipal Election pursuant to Section 10002 of the Elections Code of the State of California; and

WHEREAS, Section 10002 of the Elections Code of the State of California requires the City of Mendota to reimburse the County of Fresno in full for the services performed upon presentation of a bill to the City of Mendota; and

WHEREAS, the City Council of the City of Mendota has determined that each candidate for elective office who submits a statement to be sent to the voters with the sample ballot shall be charged a sum not greater than the actual prorated cost of printing, handling, and translating the candidate's statement, if any, incurred by the agency as a result of providing this service.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Mendota as follows:

SECTION 1. A General Municipal Election is called and ordered for the City of Mendota to be held on November 8, 2022, for the purpose of the election of three (3) members of the City Council to represent the City at-large, each for a four-year (4-year) term.

SECTION 2. Pursuant to the requirements of Section 10403 of the Elections Code of the State of California, the Board of Supervisors of the County of Fresno is hereby requested to consent and agree to the consolidation of the City of Mendota's General Municipal Election and the Statewide General Election on November 8, 2022.

SECTION 3. In accordance with the provisions of Section 10403 of the Elections Code of the State of California, the City Council of the City of Mendota acknowledges that the consolidated election will be held and conducted in accordance with the provisions of law regulating the Statewide General Election pursuant to Section 10418 of the Elections Code of the State of California.

SECTION 4. The Board of Supervisors of the County of Fresno is requested to direct the County Clerk/Registrar of Voters to take any and all steps necessary for and related to the holding of the consolidated election in a manner consistent with law, including, without limitation: the provision of all election materials and equipment; publication of notices; the hiring, training, and supervision of election officers and other election personnel; the printing and distribution of ballot materials; the translation of ballot materials; the collection of submitted ballots; the tallying and canvassing of votes; and the certification of election results.

GRANTS UPDATE

■ America Rescue Plan Act of 2021 State Local Fiscal Recovery Funds – Staff submitted the Project and Expenditure Report on April 29, 2022. The reporting period is from March 3, 2021 through March 31, 2022. The City will be required to submit future reports annually by the end of April.

- SB1383 Local Assistance Grant Program The City was approved for the SB1383 Local Assistance Grant Program for \$21,224.00. This grant program will provide aid to assist with the implementation of the Organics Regulations. Staff submitted an application to include educational workshops, purchasing organics bins for households and other materials. Our requested budget is still subject to the approval of Cal Recycle. Staff will be having a meeting to discuss the budget and eligible expenses.
- **FEMA-4482-DR-CA California Covid-19 Pandemic** Staff is in the process of submitting for reimbursement.
- **COPS Hiring Program** Staff submitted the quarterly financial report for January-March 2022.
- Regional Early Action Planning ("REAP") Program Staff received the reimbursement for the invoice requesting \$10,000.00 for the development of an online GIS mapping system. This mapping system will allow staff the ability to easily identify important planning information such as existing infrastructure, street addresses, zoning and land uses of a property/and or surrounding properties. Maps can also be printed and/or shared with developers and prospective home builders.
- Community Facilities Grant (USDA) Staff submitted reimbursement for (2) Ford Explorers for \$50,000.00. Once we receive the funds, we will inquire with the USDA about purchasing additional vehicles for Public Safety.


