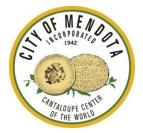

1. Council discussion and consideration of the City of Mendota Budget for Fiscal Year 2022-2023 and setting the goals for Fiscal Year 2023-2024.

Mayor Martinez introduced the item and City Manager Gonzalez provided the report.

Joseph Amador inquired about the public benefit funds that the City receives from certain cannabis companies.

Council and staff discussion was held on the City's General Fund budget, including restoring the General Funds reserve; public benefit funds that the City receives from certain

cannabis companies; the Rojas-Pierce Park Expansion Project, including the plans to create a brand new soccer field; the feasibility of constructing an indoor sports facility; the process for requesting earmarked funds from state officials, including project prerequisites; the cannabis industry in the City, including cultivation facilities and business marketing; laws pertaining to vehicle window tinting; the roundabout project at the intersection of Highways 33 and 180; the City's wastewater treatment process and the condition of the Wastewater Treatment Plant; the Mowry Bridge project; the new Mendota Police Station and City Council Chambers project and the possibility of future expansion once it is completed; the Railroad Crossing Improvements project and the condition of the current railroad crossings in the City; the Veteran's Banner program; the Mendota Stormwater Improvement Project; the need to repair/reconstruct City roads and the costs associated with such projects; and holding a Town Hall meeting to encourage and increase community participation.

Joseph Amador urged the City Council to meet with Union Pacific Railroad company to address the conditions of the railroad crossings in the City.

Discussion was held on the need for a community center and the possibility of seeking grant funding for the project; the City Council's direction as to whether the City should establish a Recreation department; potential locations for additional housing; and housing developers who may be interested in creating additional housing in the community.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA SUPPORTING AND URGING THE APPROVAL AND FUNDING OF THE GRANT APPLICATION SUBMITTED BY THE CITY OF HURON TO THE CALIFORNIA PUBLIC UTILITIES COMMISSION FOR A LOCAL AGENCY TECHNICAL ASSISTANCE GRANT

WHEREAS, the California Public Utilities Commission administers the Local Agency Technical Assistance Grant Program which provides funding to assist cities and other local agencies in their efforts to provide high speed broadband to unserved Californians; and

WHEREAS, the Local Agency Technical Assistance Grant ("LATA") funds broadband technical assistance preconstruction expenses that facilitate development of broadband, network deployment projects to areas in need, including environmental, feasibility and engineering, design studies or reports, needs assessments, market studies, broadband strategic plans, and business plans, in addition to the formation of a joint powers authority; and

WHEREAS, the City of Huron, like the City of Mendota ("City"), is a relatively small, rural city located within what is known of the West side of the County of Fresno; and

WHEREAS, if awarded, the City of Huron will use part of the grant to form a joint powers authority, which the City would be able to join, to spend the LATA grant funds for the purpose of conducting region-wide environmental, feasibility, engineering, design studies or reports, needs assessments, marketing studies, broadband strategic plans, and business plans for the development broadband throughout the West side area of the County of Fresno; and

WHEREAS, if the City were to apply for LATA funds on its own, it is unlikely, because of its size, that any significant amount of grant funds would be awarded and, given the need to establish a broadband network that covers the entire region, it is more advantageous for the City, like the City of Huron, to apply for and use the grant funds for those studies and other non-construction purposes on a regional basis.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Mendota, that the City of Mendota supports and urges the California Public Utilities Commission to grant the LATA funds requested by the City of Huron, and that the City of Mendota is specifically refraining from making its own application for these funds to enable the formation of a joint powers authority to include the City of Mendota and the

City of Huron, among others, within western Fresno County to make expenditures for purposes authorized by the LATA Grant Funding Program.

ISSUE

City Council to discuss and consider City Council Member attendance at various events.

BACKGROUND

Given the role and capacity of City Council Members, it has been encouraged that the Council Members attend various external events and trainings in order to represent the community and gain additional knowledge and expertise as it pertains to their positions.

ISSUE

City Council to provide direction to staff on making repairs to the William Robert Johnston Airport.

BACKGROUND

The City operates an airport named William Robert Johnston Airport, which is located on the east side of town. It covers approximately 130 acres, which is comprised of large parts of empty dirt land, a runway, taxiway, and an aircraft parking area. There is also a restroom building, two aircraft hangers, and a storage building.

In October 2022, CALTRANS Aeronautics Division closed the airport due to the poor conditions of both the runway and the taxiway. If the City desires to keep the airport open significant repairs must be made. City Engineer Michael Osborn estimates these repairs to cost 2-3 million dollars.

ANALYSIS

Prior to the airport closing, the Fresno Westside Mosquito Abatement had an agreement with the City to allow the use of the airport for their operations. The City also had planned to use two electric aircrafts, which were obtained through a Measure C grant, to offer residents in the City an opportunity to participate in a pilot training course. The program has stalled due to the FAA not yet approving the aircrafts since fully electric planes are too new to the industry. Aside from the Mosquito abatement operations, the airport would seldomly see any activity.

City Council should consider the long term needs of the City and whether an airport is the best use of the land. This land can be utilized for many other uses such as housing, an industrial park, or even for recreation. With an airport, any adjacent development is limited due to the flight path zone (see attached Fresno COG map).

FISCAL IMPACT

The fiscal impact for the project, will be funded through the general fund. Should the City Council decide to keep the airport open, there are potential funds that can help offset the expense of reconstructing the pavement sections, however staff anticipates an investment of \$300,000-\$500,000.

RECOMMENDATION

Staff recommends that the City Council discuss the item and provide direction to staff.

The California Department of Transportation, Division of Aeronautics (Caltrans), conducted a State permit compliance inspection and Federal Aviation Administration (FAA) Airport Master (5010) update at the William Robert Johnston Mendota Municipal Airport (Airport) (FAA Site No. 1882.2*A) on October 20, 2022. Our inspection revealed the following discrepancies which we bring to your attention:

 On October 20, 2022, Caltrans issued the City of Mendota (City) notice of a temporary suspension of the State Airport Permit closing the Airport to public use in accordance with PUC, section 21668.2, Suspension of Operations. The suspension was issued due to public safety considerations as the Runway 15/33, the parallel taxiway, and the four stub taxiway pavements were found in failed condition with potholes, cracked raveling asphalt with loose debris (FOD) strewn across the surface, and collapsed sections of pavement undermined by ground squirrel burrows (please see enclosed Photographs 1 through 5).

The pavement condition has been noted in inspection letters since 2014 and contines to deteriorate largely unaddressed by the City. The City must place a Yellow "X" at each runway end per FAA Advisory Circular (AC) 150/5340-1M, *Standards for Airport Markings*, Chapter 5.6 *Marking and Lighting of Permanently Closed Runways and Taxiways* and Figure A-27 enclosed for your reference. Caltrans has issued a Notice To Airmen (NOTAM), advising pilots that the Airport is closed until April 30, 2023. However, this suspension shall remain in effect until Caltrans determines that the conditions requiring the suspension no longer exist.

Caltrans proposes a meeting between Caltrans Aeronautics Management and City Officials to build understanding as to the cause and the requirements of the suspension and to initiate a plan to reopen the airport. Please contact me at your earliest opportunity to schedule a meeting at a time of mutual convenience.

2. The Runway Safety Area (RSA) for Runway 15/33 and the Taxiway Safety Area (TSA) for the parallel taxiway are inundated with ground squirrel burrows and mounds, which have undermined and degraded the carrying capacity of the RSA and TSA. The RSA and the TSA must be free of potential hazardous ruts, humps, depressions, or other surface variations to allow the occasional passage of aircraft without causing

structural damage to the aircraft, in accordance with FAA Advisory Circular (AC) 150/5300-13A, *Airport Design.*

- 3. The RSA for your Airport extends 240 feet beyond each runway end and is 120 feet wide (centered on the runway centerline). The TSA is 49 feet wide (24.5 feet on either side of the taxiway centerline). Please mitigate the ground squirrel infestation immediately and then grade and compact the surface to prevent further degradation of the RSA, TSA, and adjacent runway and taxiway pavements. This is a repeat discrepancy noted in past inspection letters.
- 4. The Airport Apron asphalt surface is in poor condition with large areas of alligator cracking, failing asphalt patches, and active asphalt raveling, (please see enclosed Photograph 6). The pavement condition has been noted in past inspection letters and should be addressed promptly to prevent further surface and subsurface deterioration and reduce the likelihood of FOD damage to aircraft.
- 5. At the time of the inspection, the windcone located at the center of the segmented circle was missing from its mount. Pilots rely on the windcone to depict wind direction, and speed, and to determine which runway is in use. This is a repeat discrepancy noted in past inspection letters.
- 6. The Airport's Segmented Circle with Traffic Pattern Indicators located east of Runway 15/33 is obscured by debris and is not entirely visible to pilots in the air. The debris should be removed, and the concrete blocks repainted bright white to afford maximum visibility to pilots in the air. This is a repeat discrepancy noted in past inspection letters.
- 7. Trees over 50 feet in height located adjacent to the Airport Apron penetrate the Code of Federal Regulations, (CFR) Part 77, Transitional Surface. These trees should be trimmed at or below the height indicated in Photograph 7 or be removed to maintain a clear Transitional Surface. This is a repeat discrepancy noted in past inspection letters.
- 8. A palm tree over 20 feet in height located 960 feet north of the Runway 33 Displaced Threshold and 265 feet west of the Runway 15/33 centerline penetrates the CFR Part 77, Transitional Surface. This palm should be removed or trimmed at or below the height indicated in Photograph 8 to maintain a clear Transitional Surface. This too is a repeat discrepancy.
- 9. Many current Runway and Taxiway markings are faded and do not conform to FAA AC 150/5340-1L, *Standards for Airport Markings*, and should be remarked after the Runway and Taxiway repaving project. These include:
 - The four white arrowheads located prior to the Runway 33 Displaced Threshold are incorrectly marked and should be remarked as two white arrowheads. Please remark the arrowheads as shown in AC 150/5340-1L, Standards for Airport Markings Figure A-7, Displaced Threshold Markings.

- The Runway Holding Position Marking (Hold Line) at the Runway 33 Approach End and the stub taxiway located 1,033 feet south from the Runway 15 Threshold are set at 115 feet from the runway centerline. Per AC 150/5300-13A, *Airport Design*, please relocate the hold lines to the required distance of 125 feet from the runway centerline.
- The Hold Line at the farthest south stub taxiway is mismarked as the Hold Line should not extend past the Continuous Taxiway Edge Marking. We recommend marking the Hold Line at the edge of the Edge Marking and extending the Edge Marking past the Hold Line until the taxiway narrows as depicted in AC 150/5340-1L, Standards for Airport Markings Figure A-7, Figure A-13 Holding Position Marking Details and Figure A-16 Taxiway Markings. Furthermore, there should be a 6" break between the Edge Marking and the Hold Line.
- Taxi lead-lines cross through the Hold Line on all stub taxiways. The lead lines should have a break before and after and not cross through the Hold Line as shown in AC 150/5340-1L, Standards for Airport Markings Figure A-7 and Figure A-13 Holding Position Marking Details.
- The Runway 33 Approach End Blast Pad Chevron Marking (Chevron) is not standard and should be remarked. The Chevron should be at a 45-degree angle, as shown in AC 150/5340-1L, Standards for Airport Markings, Figure A-9 Markings for Blast Pads and Stopways.

We are pleased to support and assist you in enhancing safety and utility at your Airport and look forward to continuing a cooperative relationship with the City of Mendota. Please notify us of your availability to discuss the Airport Permit suspension further and of your intended or completed actions concerning the items listed above. 


Figure A-27. Closed Runway and Taxiway Markings

Re: William Robert Johnston Municipal Airport (M90), Mendota, California Airport Closure

The Federal Aviation Administration (FAA) supports airport development and preservation throughout the United States. This is shown in the current National Plan of Integrated Airport Systems. Title 49 USC§ 47101, *et seq.*, provides for Federal financial assistance for the development of public-use airports under the Airport Improvement Program (AIP) established by the Airport and Airway Improvement Act (AAIA), as amended. Section 47107, *et seq.*, sets forth assurances to which an airport sponsor agrees as a condition of receiving Federal financial assistance.

Upon acceptance of an AIP grant, the assurances become a binding obligation between the airport sponsor and the Federal Government. A copy of the standard airport sponsor's grant assurances is enclosed. These assurances define the scope of the FAA's jurisdiction with respect to airport-related matters. In accepting AIP funds, the City of Mendota has agreed to specific Federal obligations, including the commitment to keep the William Robert Johnston Municipal Airport (M90) open and make it available for public use as an airport.

The FAA has been notified that an inspection conducted on October 20, 2022, by the California Department of Transportation (Caltrans), Division of Aeronautics resulted in a finding that Runway 15/33, the parallel taxiway, and the stub taxiway pavements are in failed condition with collapsed sections of pavement, potholes, cracked raveling asphalt, and loose debris (FOD) strewn across the surface. The failed pavement condition has remained unaddressed for some time and poses a safety hazard and could cause damage to aircraft. Based on the inspection findings, Caltrans temporarily suspended the Airport Permit in accordance with Public Utilities Code, Section 21668.2, Suspension of Operations. This suspension shall remain in effect until Caltrans determines that the conditions requiring the suspension no longer exist. Caltrans issued a Notice to Airmen (NOTAM), to advise pilots that the airport is closed to public use. Additionally, the City of Mendota must place a Yellow "X" at each runway end per FAA Advisory Circular 150/5340-1M, Standards for Airport Markings, Chapter 5.6 Marking and Lighting of Permanently Closed Runways and Taxiways and Figure A-27 enclosed for your reference.

Grant Assurance 19, *Operation and Maintenance*, requires the airport and all facilities which are necessary to serve the aeronautical users of the airport shall be operated at all times in a safe and serviceable condition and in accordance with the minimum standards as may be required or prescribed by applicable Federal, state and local agencies for maintenance and operation. The City of Mendota agreed to comply with this assurance when it signed the grant agreement and accepted Federal financial assistance.

The City of Mendota has not maintained the airport pavement in a safe and serviceable condition resulting in the revocation of the state airport license and closure of the airport. Based on this information, the City of Mendota may not be in compliance with Grant Assurance 19. Please prepare a corrective action plan addressing the issues above and submit that to the FAA with 30 days of the receipt of this letter. Failure to take corrective action could result in the initiation of FAA enforcement action through the issuance of a notice of investigation under 14 CFR Part § 16, subpart D, *Special Rules Applicable to Proceedings Initiated by the FAA*.



RESOLUTION NO. 23-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA APPROVING A PILOT TELECONFERENCING PARTICIPATION PROGRAM FOR MEMBERS OF THE PUBLIC TO ENABLE GREATER ACCESS TO PUBLIC MEETINGS

WHEREAS, the City of Mendota ("City") is dedicated to ensuring the welfare and safety of its residents and the local community; and

WHEREAS, all meetings of the City's legislative bodies are open to the public as required by the Ralph M. Brown Act (Government Code sections 54950-54963), so that any member of the public may attend, participate, and watch the City's legislative bodies conduct their business in person at the place(s) where these public meetings occur; and

WHEREAS, throughout the COVID-19 pandemic emergency, standard public meeting posting and access procedures related to the teleconferencing requirements contained in Government Code section 54953, subdivision (b)(3), were suspended pursuant to Executive Order N-29-20 and California's COVID-19-related State of Emergency, which led to remote participation by both members of the public and the City's legislative bodies via Zoom teleconferencing software for a time; and

WHEREAS, Executive Order N-29-20's provisions expired on October 1, 2021, but, prior to this expiration, Assembly Bill 361 amended Government Code section 54953 to allow local governments to continue using teleconferencing attendance without the standard meeting posting and access procedures to, among other things, protect imminent health risks; and

WHEREAS, pursuant to Assembly Bill 361's provisions, the City continued offering Zoom teleconferencing attendance and participation options at meetings of the City's legislative bodies for a time; and

WHEREAS, at its March 22, 2022, regular meeting, the City Council discussed and considered whether to continue offering Zoom teleconferencing services at City meetings, and adopted Resolution No. 22-22 to transition the City's meetings back to inperson participation; and

WHEREAS, Resolution No. 22-22 cited the City Council's intention to foster more meaningful discussion and a greater sense of community by returning to in-person participation at public meetings of the City's legislative bodies; and

WHEREAS, California's COVID-19-related State of Emergency is scheduled to end on February 28, 2023; and

WHEREAS, prior to that expiration, Assembly Bill 2449 made further amendments to Government Code section 54953 to allow the members of a local government's legislative body to participate in meetings via teleconferencing without complying with subdivision (b)(3)'s standard posting and access requirements; and

WHEREAS, to utilize Assembly Bill 2449's amendments, which are primarily contained in Government Code section 54953, subdivision (f), the City must, among other things, ensure: (1) a quorum of the City's legislative body participates in person from a singular physical location clearly identified on the agenda; (2) offer remote teleconferencing services that allow members of the public to hear, visually observe, and address the legislative body; and (3) only allow remote participation by a member of the legislative body for just cause (twice per calendar year, per member) or by vote of the legislative body in emergency circumstances (no more than three consecutive months or twenty percent of a calendar year's meetings, per member); and

WHEREAS, the City does not currently offer remote teleconferencing services to the public, and, as a result, cannot make use of Assembly Bill 2449's provisions, even where convenient or otherwise necessary for City business; and

WHEREAS, members of the City Council have been approached by the public, requesting the City recommence offering Zoom remote teleconferencing services for public meetings of the City's legislative bodies; and

WHEREAS, offering Zoom remote teleconferencing services at public meetings of the City's legislative bodies would cost the City approximately \$839.90 per year in licensing fees and require additional work by City staff to manage and maintain these services prior to and during meetings; and

WHEREAS, the City Council has discussed and considered the costs and potential benefits of recommencing Zoom remote teleconferencing offerings to the public, and wishes to initiate a pilot program wherein the City will recommence offering these services to the public for a limited time before making a future determination regarding whether to institute these additional service offerings on a permanent basis.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Mendota, that the City will offer Zoom remote teleconferencing services to the public at all public meetings of the City's legislative bodies for a period of ______ months, set to expire on ______, 2023, before making a further determination regarding whether to provide this additional service offering on a permanent basis.






