A motion was made to nominate Councilor Castro as Mayor by Councilor Amador, seconded by Councilor Martinez; unanimously approved (5 ayes).

A motion was made to nominate Councilor Martinez as Mayor Pro Tem by Mayor Castro, seconded by Councilor Amador; unanimously approved (5 ayes).

The Council thanked Councilor Silva for his service as Mayor.

Dino Perez (Westside Youth Inc.) – thanked the Council and staff for their hard work and assistance to Westside Youth and reported on various programs and upcoming events.

Discussion was held on the importance of local organizations coming together to serve

San Juana Prieto (583 L Street) – stated that there is an abundance of individuals conducting business within the City without the necessary permits.

Discussion was held on how the issue can be addressed and of staff meeting with Ms. Prieto in the future.

Alex Blanco – inquired on what is being done to address gang activity.

Discussion was held on increasing public safety funding and the issue being discussed in a later portion of agenda.

Angela Rivera – congratulated the new Council Members.

Oscar Rivas (Mendota Police Officers Association) – thanked the City Council for their support of the officers.

Flor Larreynaga – thanked the outgoing and newly elected Council Members.

Teresa Ayala – congratulated the newly elected Council Members.

Marc Banuelos (630 Gaxiola) – congratulated the newly elected Council Members and thanked the Council for their support.

3. Proposed adoption of **Resolution No. 16-90**, approving the modified City of Mendota 401(K) Profit Sharing Plan to reflect CalPERS participants.

A request was made to pull item 3 for discussion.

A motion was made to adopt items 1 and 2 of the Consent Calendar by Councilor Amador, seconded by Councilor Silva; unanimously approved (5 ayes).

3. Proposed adoption of **Resolution No. 16-90**, approving the modified City of Mendota 401(K) Profit Sharing Plan to reflect CalPERS participants.

Discussion was held on the background of the item.

A motion was made to adopt item 3 of the Consent Calendar by Councilor Amador, seconded by Councilor Rosales; unanimously approved (5 ayes).

BUSINESS

1. Proposed adoption of **Resolution No. 16-91**, acknowledging receipt of the annual audit of city funds.

Mayor Castro introduced the item.

Fausto Hinojosa from Price, Paige, & Company congratulated the new Council and reported on the purpose of the audit; the result of the Fiscal Year 2015/2016 audit; described the audit process; reported on the status of the various revenue funds that the City has; and stated that the City received a clean audit result.

Discussion was held on the various types of opinions that an audit can have and the City receiving an unmodified opinion.

City Manager DiMaggio thanked Price, Paige, and Company for their work and thanked Finance Director Marquez for his work.

Discussion was held on the importance of transparency.

Raul Varela (263 J Street) – asked if the City could provide the information regarding the audit to the public in Spanish.

Sergio Valdez – inquired on the deficit in the General Fund.

A motion was made to adopt Resolution No. 16-91 by Councilor Amador, seconded by Mayor Pro Tem Martinez; unanimously approved (5 ayes).

2. Council discussion and possible direction on presenting city employees with a \$25 voucher.

Mayor Castro introduced the item and City Manager DiMaggio thanked the Council for their consideration to appreciate staff in this form and reported on the concerns he has regarding the issue.

City Attorney Kinsey reported on the structural and legal issues concerning providing staff with vouchers and shared alternative ways that the Council could recognize staff.

Discussion was held on the upcoming Holiday potluck.

A motion was made to no longer pursue the item by Councilor Amador, seconded by Councilor Rosales; unanimously approved (5 ayes).

3. Council discussion and possible direction on mechanisms to increase funding for police department.

Mayor Castro introduced the item and City Attorney Kinsey reported on possible ways to increase public safety funding, such as a tax measure; the possibility of holding a Special Election in June 2017 for the measure; the amount of votes that are needed in order to pass the tax measure; the process of holding a Special Election; the available dates for the proposed election; the option to have a mail-in ballot election; and the purpose of the proposed tax measure being to increase funding for the police department.

Discussion was held on which election method to move forward with; other funding options that are available; and attracting businesses.

Council consensus was reached to move forward with a mail-in ballot election.

4. Proposed adoption of **Resolution No. 16-92**, approving Agreement for Preparation of an Environmental Document and Related City Services.

Mayor Castro introduced the item and City Attorney Kinsey summarized the report including that the purpose of the agreement is that the City will be reimbursed for expenses incurred in preparing environmental documents for the proposed Waste Water Treatment Plant project.

Discussion was held on the benefits of the project.

A motion was made to adopt Resolution No. 16-92 by Councilor Amador, seconded by Councilor Silva; unanimously approved (5 ayes).

PUBLIC HEARING

1. Proposed adoption of **Ordinance No. 16-11**, modifying Section 3.20.040 of the Mendota Municipal Code (Administration of surplus and conduct of sale).

Mayor Castro introduced the item and Economic Development Manager Flood reported that the ordinance would add provisions to the sale of personal property ordinance and shared the benefits of adding the proposed provisions.

Discussion was held on how the property would be sold under the new provisions.

At 8:16 p.m. Mayor Castro opened the hearing to the public.

Raul Varela (263 J Street) – shared other ways the City can advertise the surplus sales.

At 8:19 p.m. Mayor Castro closed the hearing to the public.

A motion was made to adopt Ordinance No. 16-11 by Councilor Rosales, seconded by Mayor Pro Tem Martinez; approved (4 ayes, abstain: Silva).

2. Proposed adoption of **Ordinance No. 16-10**, removing the 48 hour requirement for a Noise Permit.

Mayor Castro introduced the item and Economic Development Manager Flood reported that the ordinance would remove the 48 hour noise permit notice requirement and summarized the purpose of the Noise Ordinance.

At 8:26 p.m. Mayor Castro opened the hearing to the public and, seeing no one present wishing to comment, closed it in that same minute.

A motion was made to adopt Ordinance No. 16-10 by Councilor Silva, seconded by Councilor Amador; unanimously approved (5 ayes).

3. Consideration of extension of **Ordinance No. 16-12**, an Interim Urgency Ordinance Enacting a Temporary Moratorium on New and Relocated Wireless Telecommunications Facilities Within Public Right-of-Ways, Pursuant to Government Code Section 65858.

Mayor Castro introduced the item and City Manager DiMaggio reported that the item would be extending an ordinance that will prevent wireless telecommunication facilities within public right-of-ways for a certain period of time.

Discussion was held on a meeting that was held with AT&T.

At 8:29 p.m. Mayor Silva opened the hearing to the public and, seeing no one present wishing to comment, closed it in that same minute.

A motion was made to adopt Ordinance No. 16-12 by Councilor Amador, seconded by Mayor Pro Tem Martinez; unanimously approved (5 ayes).

1. Code Enforcement a) Monthly Report

Economic Development Manager Flood summarized the report including the department's focus for the month of November; ensuring that businesses had business licenses; and stated the importance of having the public report violations.

2. Police Department a) Monthly Report

Chief of Police Andreotti summarized the report including significant cases for the month of November and provided a personnel update.

Discussion was held on the good work that the police department does.

Teresa Ayala – stated that her husband caught someone looking inside their home but that they did not contact dispatch.

Flor Larreynaga – stated that some residents are not pleased with the service they received from an officer and inquired on when a police report should be created.

3. City Attorney a) Update

City Attorney Kinsey reported on the items that his office is working on that are pertinent to the City.

4. City Manager

City Manager DiMaggio reported on the possibility of holding a Joint Meeting of the City Council and Mendota Unified School Board of Trustees in January and the City's participation in the upcoming Christmas Parade.

ISSUE

Should the Council authorize the City Manager to initiate the process to dissolve the West County Solid Waste Planning Committee (WCSWPC)?

BACKGROUND

In the late 1960s and 1970s, the City, the County, and the Cities of Coalinga, Firebaugh, Huron, Kerman, and San Joaquin, in response to the newly adopted County Solid Waste Management Plan, executed a Joint Powers Agreement and related Memorandum of Understanding to create the WCSWPC. The WCSWPC has the ability to site, operate facilities, and implement regional programs for the urban area. The passage of Assembly Bill 939, in 1989, required that each County and city establish and implement jurisdiction-specific recycling and diversion plans. The County and the 15 incorporated cities executed a Memorandum of Understanding to address countywide regional programs, which are coordinated through the AB 939 MOU Committee.

AB939 also included the establishment of an Integrated Waste Management Local Task Force (LTF) by the County. The LTF reviews and approves the local and countywide planning documents (e.g., Source Reduction and Recycling Elements (SRREs), Household Hazardous Waste Elements (HHWEs), Non-Disposal Facility Elements (NDFEs), Countywide Integrated Waste Management Plan (IWMP) and Countywide Siting Element (CSE)), which were developed to comply with AB 939 regulations. Fresno County's LTF was formed in 1990 and was comprised of fifteen members. The membership included nine members appointed by the Board of Supervisors.

Additionally, in 1993 the County, in coordination with the 15 incorporated cities, adopted an AB 939 Memorandum of Understanding (MOU) to address Statemandates solid waste programs, develop plans, and clarify the responsibilities of the County in on-going planning and implementation of regional countywide programs. The MOU created an "AB 939 MOU Committee" which includes a representative of each of the jurisdictions within the County and functions as a countywide planning agency for regional solid waste and recycling programs and activities.

On October 27, 2016, the WCSWPC members comprised of Brian Pacheco, Jose Ornelas, Mercedes Garcia and Nick Escandon met and approved the dissolution of the WCSWPC by a vote of 4-0. The Joint Powers Agreement stipulates that the WCSWPC can be dissolved upon mutual agreement of four member agencies. The WCSWPC members directed their staff to work with each jurisdiction's staff and coordinate the submittal of requisite documents to each one of the governing bodies to request approval to dissolve the commission and terminate the Joint Power Agreement.

ANALYSIS

The recommended actions will allow the City to begin the process to coordinate with the partnering jurisdictions to dissolve the inactive and obsolete West County Solid Waste Planning Committee (WCSWPC), and to terminate the related Joint Power Agreement (JPA) by mutual agreement. The dissolution of the subregional committee and consolidation of activities through the existing Assembly Bill 939 Memorandum of Understanding Committee (AB 939 MOU Committee) will aid in the efficient management of countywide state-mandated programs and plans (e.g., education, public outreach, household hazardous waste (HHW) management programs, and Non-Disposal Facility Plan updates, etc.).

Therefore, staff recommends that the Council adopt the attached Resolution No. 17-03 which provides for the dissolution of the WCSWPC. This action will allow the City to continue to implement countywide Assembly Bill (AB) 939 and other Statemandated programs and plans, which include education, public outreach, and household hazardous waste (HHW) management programs under the existing Assembly Bill 939 Memorandum of Understanding Committee (AB 939 MOU Committee). Once authorization is received from all participating jurisdictions, WCSWPC staff will take the necessary steps to dissolve the inactive and obsolete West County Solid Waste Planning Committee (WCSWPC), and to commence the process to terminate the respective Joint Power Agreement (JPA) by mutual agreement.

FISCAL IMPACT

RECOMMENDATION

Council adopt Resolution No. 17-03, authorizing the City Manager to take the necessary steps and execute any needed documents for the dissolution of the WCSWPC, including the associated JPA.

SUBJECT: Dissolution of the West County Solid Waste Planning Committee

Dear Mr. DiMaggio:

On October 27, 2016, the West County Solid Waste Planning Committee (WCSWPC) comprised of the City of Coalinga (Mercedes Garcia), the City of San Joaquin (Jose Orenelas), the City of Huron (Nick Escandon) and the Fresno County Board of Supervisor (Brian Pacheco) met and approved the dissolution of the WCSWPC through mutual agreement by a vote of 4-0. At this meeting, the WCSWPC also directed Fresno County staff to prepare requisite documentation to request approvals from the County Board of Supervisors and the governing bodies of the Cities of Coalinga, Firebaugh, Huron, Kerman, Mendota and San Joaquin for dissolution. County staff has prepared the attached items for your use. Please feel free to send to City Counsel for review and edit to comply with the City's format. These documents will provide the details for you to format a Council report and resolutions to receive approvals and a concurrence with the actions proposed. The following documentation is attached for your use:

• Draft Council Agenda Item with Resolution to authorize dissolution of the WCSWPC and termination of the associated JPA.

For your edification, staff has provided the following background information:

West County Solid Waste Planning Committee (WCSWPC)

The WCSWPC was formed through a Joint Powers Agreement (JPA) between the Cities of Coalinga, Firebaugh, Huron, Kerman, Mendota and San Joaquin and the County of Fresno in 1977 for the purpose of solid waste management within the region. In 1990, two members of the WCSWPC were appointed to the LTF discussed below. The Committee had not met recently and is currently considered in active and obsolete.

Integrated Waste Management Local Task Force (LTF)

The California Integrated Waste Management Act of 1989 (Assembly Bill 939, Sher, Chapter 1095, Statues of 1989 [AB 939]), required that each County form an LTF to review and approve the local and countywide planning documents developed pursuant to AB 939. Fresno County's LTF was formed in 1990 and met regularly to review the local Source Reduction and Recycling Elements (SRREs), Household Hazardous Waste Elements (HHWEs), Non-Disposal Facility Elements (NDFEs), Countywide Integrated Waste Management Plan (IWMP) and Countywide Siting Element (CSE). The LTF reviews amendments to the local and countywide planning documents and the Five-Year Countywide Plan Update.

AB 939 MOU Committee

The County, in coordination with the 15 incorporated cities, adopted an AB 939 Memorandum of Understanding (MOU) in 1993 to clarify the responsibilities of the County in on-going planning and implementation of countywide solid waste programs. The MOU created an "AB 939 MOU Committee" which includes a representative of each of the jurisdictions within the County and functions as a countywide planning agency for regional solid waste and recycling programs and activities. Understanding membership to the LTF was partially made up from members of the WCSWPC and other committees and that this Committee is being dissolved, another representative committee needs to serve in this capacity and perform the functions of the LTF. During a recent AB 939 MOU Committee Meeting on October 12, 2016, the committee members unanimously voted for the LTF to be restructured into the AB 939 MOU Committee. The dissolution of the WCSWPC and consolidation of LTF activities through the countywide AB 939 MOU Committee will aid in the efficient management of countywide solid waste programs.

ISSUE:

Should the City Council approve a Resolution declaring a State of Emergency regarding criminal gang related violent crime.

BACKGROUND:

Over the last few years the City of Mendota has experienced a large number of criminal gang related violent crimes. Additionally, there have been a number of actual and suspected criminal gang related violent crimes outside the City of Mendota that involve Mendota residents.

Mendota Police Department's current staffing and budget do not allow for the assigning or hiring of personnel dedicated to specifically address the criminal gang related violent crime activity.

The purpose of this Resolution is to provide information regarding the state of criminal gang related violent crime activity within and connected to the City of Mendota to leadership, supervisors, and legislatures at all levels of government.

This Resolution supports the City of Mendota's request for additional Law Enforcement resources and funding to address the criminal gang related violent crime plaguing its citizens.

RECOMMENDATION:

Staff recommends that the Council adopt Resolution No. 17-05, adopting the Resolution declaring a State of Emergency regarding criminal gang related violent crime.

RESOLUTION NO. 17-05

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA TO DECLARE A STATE OF EMERGENCY IN RESPONSE TO CRIMINAL GANG RELATED VIOLENT CRIME

WHEREAS, in 2009 the City of Mendota reestablished the Mendota Police Department and empowered it with the duty and responsibility to protect and serve the community and citizens of Mendota; and

WHEREAS, allocated staffing of law enforcement officers in the Mendota Police Department total twelve (12) permanent-full time personnel; and

WHEREAS, the Mendota Police Department does not have available funding to increase staffing for a full-time detective assignment or special investigator; and

WHEREAS, since 2009 Mendota Police Officers have encountered subjects claiming affiliation or association with known criminal gangs; and

WHEREAS, since 2009 criminal gang affiliated subjects in Mendota have committed violent crimes; and

WHEREAS, between 2009 and 2015 Mendota Police Officers have noticed an increase of violent crimes associated with criminal gang affiliated subjects; and

WHEREAS, criminal gang affiliated subjects who reside or have been contacted in the City of Mendota have been connected to locations within the State of California and nationally where criminal activity is associated to them or their criminal gang; and

WHEREAS, the culture of criminal gangs include criminal activity and the use of intimidation and violence; and

WHEREAS, in January 2015 an attempt-Homicide occurred in the City of Mendota where a criminal gang affiliated high school student stabbed another criminal gang affiliated student. (Mendota PD Case #15-148); and

WHEREAS, in April 2015 a Homicide occurred in the City of Mendota where the victim had ties with a criminal gang and the killers are suspected criminal gang affiliates. (Fresno Sheriff Case #15-5143); and

WHEREAS, in May 2015 an attempt-Homicide occurred in the City of Mendota where the victim is a known associate of a criminal gang and was shot multiple times by suspected criminal gang affiliates. (Mendota PD Case #15-684); and

WHEREAS, in May 2015 a Homicide occurred outside the City of Mendota where the victim was a Mendota resident and he and his girlfriend affiliated with a criminal gang. (Fresno Sheriff Case #15-7900); and

WHEREAS, in May 2015 a Homicide occurred outside the City of Firebaugh where a known criminal gang affiliated subject and Mendota resident killed the victim who was also a resident of Mendota. (Fresno Sheriff Case #15-7855); and

WHEREAS, in July 2015 a Homicide occurred outside Coalinga where the victim was associated with a criminal gang in Mendota, (Fresno Sheriff Case #15-10712); and

WHEREAS, in September 2015 a Homicide occurred in the City of Mendota where the victim was killed in a manner consistent with prior killings associated to known criminal gangs. (Fresno Sheriff Case #15-13824); and

WHEREAS, in September 2015 an attempt-Homicide occurred in the City of Mendota where the victim was confronted by criminal gang affiliated suspects and then shot. (Mendota PD Case #15-1521); and

WHEREAS, in January 2016 a Homicide occurred in the County of San Benito where the victim was a known criminal gang affiliated resident of Mendota. The killing was consistent with other know criminal gang related homicides. (San Benito Sheriff Case #16-0102); and

WHEREAS, in January 2016 an assault with a deadly weapon occurred in the City of Mendota where the victim is a known affiliate of a criminal gang and was attacked by a subject with a machete. (Mendota PD Case #16-143): and

WHEREAS, in April 2016 an assault with a deadly weapon occurred in the City of Mendota where the victim is an affiliate of a criminal gang and was stabbed in the face by a criminal gang affiliate. (Mendota PD Case #16-0489); and.

WHEREAS, in July 2016 an assault with a deadly weapon occurred in the City of Mendota where the victim is an affiliate of a criminal gang and was threatened with a handgun by another criminal gang affiliate. (Mendota PD Case #16-1166); and

WHEREAS, in July 2016 an assault with a deadly weapon occurred in the City of Mendota where the suspect, a criminal gang affiliated high school student attempted to stab another criminal gang affiliated high school student. (Mendota PD Case #16-1280); and

WHEREAS, in July 2016 a Homicide occurred in the City of Mendota where the victim who associated with a criminal gang and was killed in a manner consistent with other known gang homicides. (Fresno Sheriff Case #16-11207); and

WHEREAS, in September 2016 an assault with a deadly weapon occurred in the City of Mendota where a criminal gang affiliate caused head injuries to another criminal gang affiliate. (Mendota PD Case 316-1707); and

WHEREAS, in October 2016 a double Homicide occurred in the City of Mendota where the female victim was a known associate of a criminal gang and her male friend were killed in a manner consistent with other known criminal gang related Homicides. (Fresno Sheriff Case #16-17355); and

WHEREAS, in November 2016 an attempt-Homicide occurred outside the City of Mendota where the victim who was visiting residents in Mendota and is associated with a criminal gang, was shot by suspected criminal gang affiliates. (Fresno Sheriff Case #16-18361); and

WHEREAS, in December 2016 a Homicide occurred in the City of Mendota where the victim was known to associate with a criminal gang was killed by suspected criminal gang affiliates. (Fresno Sheriff Case #16-18958)

WHEREAS, Mendota Police Officers have received information that threats of violence have been made by criminal gang affiliated subjects towards Mendota citizens who choose not to report the incidents for fear of such violence; and

WHEREAS, most of the criminal gang related violence within or associated to the City of Mendota is being committed by affiliates of the criminal gangs known as Mara Salvatrucha or MS-13 and Bulldogs; and

WHEREAS, with the steady increase of violent crime associated to criminal gangs and the lack of revenue to increase Mendota Police Department staffing, the Mendota Police Department is not effectively staffed or equipped to directly impact the criminal gang activity; and

WHEREAS, the City Council of the City of Mendota will provide this Resolution, but not limit it to, members of the Fresno County Board of Supervisors, California State Assembly and Senate, United States House of Representatives and Senate.

NOW THEREFORE, BE IT RESOLVED that the City Council of the City of Mendota, based upon the violent crime rate associated to criminal gang activity, does hereby declare a State of Emergency.

ISSUE

Should the Council introduce Ordinance No. 17-01 and waive its first reading in full?

BACKGROUND

The applicant proposes to subdivide the existing legal lot northeast of McCabe and Sorensen Avenues (191 Sorensen Avenue; APN 012-200-26; Parcel 2 of Parcel Map No. 87-01, Book 47 Page 60 of Parcels Maps) into two lots. In order to facilitate this, the site must be rezoned to provide consistency between the zoning and the General Plan land use. The proposal originally contemplated an amendment to the General Plan Land Use for the site from Medium Density Residential to High Density Residential to accommodate rezoning to R-3. At its regular meeting on October 11, 2016 at which the proposed rezoning ordinance was introduced, the City Council unanimously denied the change of zone, effectively mooting any consideration of the accompanying General Plan amendment. On December 20, 2016, the Planning Commission considered a revised proposal to rezone the entirety of the site to R-1. It adopted Resolution No. PC 16-06, recommending in part that the City Council approve the rezoning of the site as amended. If the City Council introduces and waives the first reading of the new rezoning ordinance, the tentative parcel map and the second reading of the rezoning ordinance will be brought to the Council for consideration at its January 24, 2017 meeting.

ANALYSIS

The site currently contains three distinct zone districts: R-1, R-3, and C-3 (see exhibit). Ordinance No. 17-01 would rezone the entirety of the property to the R-1 Single-Family/ Medium Density Residential zone. The new zoning could ultimately support a standard single-family residential project, although no development is proposed at this time. Govt. Code Section 65860 requires that zoning be consistent with the General Plan. Following adoption of the General Plan Update in 2009, the City initiated an extensive rezoning of parcels to provide consistency with the General Plan. The subject parcel has been planned for Medium Density Residential use since at least the 1991 General Plan, but has never been rezoned to the corresponding R-1 district. The current proposal would provide the required consistency.


Proposals to rezone property consistent with an adopted General Plan for which an EIR was certified are not subject to additional review under CEQA except in limited circumstances, none of which apply in this case.

FISCAL IMPACT

There would be no impact to City funds. Costs associated with application processing are typically borne by the applicant. If the site eventually develops, the City would collect impact fees to fund capital improvements.

RECOMMENDATION

Staff recommends that the City Council introduces Ordinance No. 17-01 and waives its first reading, setting a public hearing date for the second reading and adoption to occur at its regular meeting of January 24, 2017.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MENDOTA AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF MENDOTA TO REFLECT A CHANGE OF ZONE FOR ASSESSOR'S PARCEL NUMBER 012-200-26 FROM THE R-1 SINGLE-FAMILY/ MEDIUM DENSITY RESIDENTIAL, R-3 HIGH DENSITY MULTIPLE FAMILY RESIDENTIAL, AND C-3 CENTRAL BUSINESS AND SHOPPING DISTRICTS TO THE R-1 SINGLE-FAMILY/ MEDIUM DENSITY DISTRICTRESIDENTIAL

The City Council of the City of Mendota does hereby ordain as follows:

- <u>Section 1.</u> The Official Zoning Map of the City of Mendota is hereby amended to reflect the entirety of Fresno County Assessor's Parcel No. 012-200-26, more particularly described as Parcel 2 of Parcel Map No. 87-01, recorded at Book 47, Page 60 of Parcel Maps, Fresno County Records, as being in the R-1 Single-Family/Medium Density Residential District as illustrated in Attachment "A" to this ordinance.
- <u>Section 2.</u> If any section, subsection, sentence, clause, phrase, or word of this ordinance is for any reason held to be unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The Mendota City Council hereby declares that it would have passed and adopted this ordinance and each and all provisions thereof irrespective of the fact that any one or more of said provisions be declared unconstitutional.
- <u>Section 3.</u> Within fifteen (15) days of the adoption of this ordinance, a summary thereof, including the names of the City Council Members voting for and against it, shall be prepared by the City Attorney for publication in the *Firebaugh-Mendota Journal*, and a certified copy of the Ordinance shall be posted in the office of the City Clerk.
- <u>Section 4.</u> This ordinance shall become effective and in full force at 12:00 midnight on the 31st day following its adoption.



ISSUE

Should the City Council approve a resolution that establishes the City's own Groundwater Sustainability Agency?

BACKGROUND

In 2014, the legislature passed, and the Governor signed the Groundwater Sustainability Management Act (SGMA). The SGMA requires that prior to June 30, 2017, all cities in California must either form their own independent Groundwater Sustainability Agency (GSA), or join with other entities in the formation of a multi-party Groundwater Sustainability Agency.

Over the past several months staff has considered several alternatives on how to address this requirement. First, staff considered joining the Delta-Mendota Canal District and their affiliates in the formation of a GSA. This effort seemed somewhat disorganized and disjointed. Staff also considered joining the Westlands GSA, but Westlands proceeded too quickly and staff was not invited to participate in their formation process.

The third, and most reasonable alternative, came out of a meeting between the City Manager and the Executive Director of the Central California Irrigation District (CCID). All of the cities either in or bordering CCID territory have formed their own GSA's and will participate cooperatively with CCID in the formulation of a comprehensive Groundwater Sustainability Plan (GSP) – also required under the SGMA. Mendota was invited to do the same.

This alternative presents the most economical way for the City to both control its own water resources - through forming its own GSA - as well as comply with state law in preparing the required GSP in conjunction with a larger entity with far more resources.

ANALYSIS

The SGMA requires that all cities do two things: 1) form their own GSA or participate in a multi-party GSA; and 2) prepare, either separately or in conjunction with other entities, a GSP.

There are no known costs associated with Mendota forming their own GSA. It is simply a procedural step whereby a government agency declares their intention to control the groundwater resources in the delineated area. There are no costs, board meetings, staffing costs, etc...associated with becoming our own GSA – other than the preparation of the required GSP (explained below).

The law does require, however, that we prepare, either individually or with other entities, a GSP. If Mendota were to proceed alone in preparing our own GSP, the costs would be in the hundreds of thousands of dollars. However, by joining a larger organized group – consisting of the CCID and all of the cities in their boundaries – the costs of preparing a GSP are significantly defrayed.

This is a time sensitive item and it is strongly encouraged that the Council act at this time is approving the formation of the GSA. Following the Council's approval, there is still a 60-day review period at the state level and the potential for the GSA to be opposed by an interested party. In any event, the City needs to have a GSA formed, be part of another GSA, or simply be absorbed by the Fresno County GSA, by June 2017. The option before Council allows the City to control its own destiny.

FISCAL IMPACT

By joining a larger group, as proposed, the costs of preparing the GSP are reduced significantly. In the initial discussions with CCID staff, it is anticipated that Mendota's costs for our share of the GSP will be minimal – under \$10,000.

In the event we were forced to prepare our own GSP, it is likely that the costs would exceed \$250,000.

Therefore, the proposal before Council to form our own GSA and participate with CCID and the other affiliated cities in the preparation of a GSP is the fiscally superior alternative.

RECOMMENDATION

Staff recommends that the City Council approve the attached resolution approving the formation of the Mendota Groundwater Sustainability Agency.

Pursuant to Section 10723.8 of the Water Code, adopted as part of the Sustainable Groundwater Management Act ("SGMA"), I am providing notice on behalf of the City of Mendota (the "City") to inform you that the City has elected to be established as the Groundwater Sustainability Agency ("GSA") for portions of the DWR Groundwater Basin No. 5-022.07 (the "Delta-Mendota Subbasin") underlying the City limits of the City of Mendota. The extent of the boundary proposed to be managed by the City of Mendota GSA are shown in Exhibit "A."

On January 10, 2017, the Mendota City Council held a public hearing regarding the establishment of a GSA encompassing the portions of the Delta Mendota Subbasin lying within the City of Mendota's city limits. The City's public hearing was conducted in accordance with Section 10723(b) of the Water Code, and was noticed in accordance with Section 6066 of the Government Code. (See Exhibit "B.") After holding the January 10, 2017, public hearing, the City Council adopted Resolution No. 17-01, establishing the City of Mendota Groundwater Sustainability Agency, a copy of which is enclosed as Exhibit "C." No new bylaws or ordinances were adopted in conjunction with this action.

Pursuant to Section 10723.2 of the Water Code, the City has developed a list of interested parties, and will continue to amend the list as necessary during the development process for the Groundwater Sustainability Plan (the "GSP"). 

Pursuant to Section 10723.2 of the Water Code, the City has developed a list of interested parties, and will continue to amend the list as necessary during the development process for the Groundwater Sustainability Plan (the "GSP"). The City has considered, and will continue to consider, the interests of all beneficial uses and users of groundwater, as well as those responsible for implementing GSPs. The City will also solicit feedback and engage in discussions with other interested parties during GSP development. The interested parties include, but are not limited to, the following:

1. **Agricultural Users**. There are a limited number of agricultural users within the City of Mendota. The City will engage directly with those users. Outside the City limits, the City will work collaboratively with other GSAs within the Delta-Mendota Subbasin, including those that provide direct service to agricultural users, to consider the interests of agricultural users within the Delta-Mendota Subbasin.

2. **Domestic Well Owners**. There are a limited number of private domestic well owners within the City limits. The City will coordinate with the Fresno County Environmental Health Department, and use public outreach tools to identify such owners and their interests such that they may be considered. Outside the City limits, the City will work collaboratively with other GSAs within the Delta-Mendota Subbasin, including those that allow the development of domestic wells, to identify and consider their interests.

3. **Municipal Well Operators**. The City is the owner and operator of municipal wells within the City of Mendota GSA boundaries. There are no other municipal water well operators within the City of Mendota GSA.

4. **Public Water Systems**. Currently, the City operates and maintains a public water system (Water System ID: 1010021) within the City of Mendota GSA. There are no other public water systems within the City of Mendota GSA.

5. **Local Land Use Planning Agencies**. The City of Mendota is the local land use and planning agency within the City of Mendota GSA boundary. Outside the City limits, the City will work collaboratively with the County of Fresno, which functions as a local land-use planning agency for the unincorporated area within the Delta-Mendota Subbasin.

6. **Environmental Users of Groundwater**. The City is unaware of any known environmental users of groundwater within the Delta-Mendota Subbasin. The City of Mendota GSA will seek to identify such users through the public outreach process to be conducted as part of the preparation of the groundwater sustainability plan.

7. **Surface Water Users**. The city is unaware of any users of surface water within the City of Mendota GSA boundary. The City of Mendota GSA will seek to identify any such

users through the public outreach process to be conducted as part of the preparation of the Groundwater Sustainability Plan.

8. Federal Government (including, but not limited to, the military and managers of federal lands). The City is unaware of any lands owned by the federal government within the boundaries of the City of Mendota GSA. The City of Mendota GSA will seek to identify any such users through the public outreach process to be conducted as part of the preparation of the Groundwater Sustainability Plan.

9. **California Native American Tribes**. There are no known California Native American Tribes maintaining a presence within the boundaries of the City of Mendota GSA. The City of Mendota GSA will seek to identify any such California Native American Tribes through the public outreach process to be conducted as part of the preparation of the Groundwater Sustainability Plan.

10. **Disadvantaged Communities**. The City of Mendota is considered a disadvantage community, as our portions of the County of Fresno. There are also more narrowly defined DACS within the Delta-Mendota Subbasin. The City will engage disadvantaged populations within and outside the City of Mendota GSA boundaries through public outreach tools and through the points of contact that of been identified through prior planning efforts.

11. Entities Listed in Section 10927 that Are Monitoring. The City of Mendota collaborates with the County of Fresno and Central California Irrigation District (CCID) in the collection of groundwater data as part of the California Statewide Groundwater Elevation Monitoring (CASGEM) program. The City will coordinate closely with the County, CCID, and other interests with respect to the continued collection of this data.

RESOLUTION NO. 17-01

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA APPROVING THE FORMATION OF A GROUNDWATER SUSTAINABILITY AGENCY UNDER THE SUSTAINABLE GROUNDWATER MANAGEMENT ACT

WHEREAS, the Sustainable Groundwater Management Act of 2014 ("SGMA") was signed into law on September 16, 2014, and became effective on January 1, 2015; and

WHEREAS, SGMA requires that each California groundwater basin or sub-basin be managed by a Groundwater Sustainability Agency ("GSA"), or multiple GSAs, and that such management be implemented pursuant to an approved Groundwater Sustainability Plan ("GSP") or multiple GSPs; and

WHEREAS, the City of Mendota ("City") overlies a sub-basin of the San Joaquin Valley Groundwater Basin known as the Delta-Mendota Subbasin (Basin No. 5-22.07 in the Department of Water Resources' CASGEM system), an unadjudicated groundwater basin overlying portions of Stanislaus, Merced, Madera, and Fresno Counties (the "Delta-Mendota Subbasin"); and

WHEREAS, Section 10723(a) of the Water Code authorizes any local agency or combination of local agencies overlying a groundwater basin to elect to be a GSA for that basin; and

WHEREAS, Section 10721(j) of the Water Code defines a GSA as one or more local agencies that implement the provisions of SGMA; and

WHEREAS, the City, a local public agency overlying portions of the Delta-Mendota Subbasin, is authorized to be a GSA for the portions of the Delta-Mendota Subbasin within the City's jurisdictional boundaries; and

WHEREAS, retaining local control over sustainable groundwater management and land use is beneficial to the health, safety, and welfare of City residents; and

WHEREAS, the City is in a unique position and shall consider the interests of all beneficial users of groundwater, and those responsible for implementing groundwater sustainability plans as required by SGMA; and

WHEREAS, SGMA requires that a local agency electing to become a GSA must notify the Department of Water Resources of its intent to undertake sustainable groundwater management within a basin; and

WHEREAS, the City intends to work cooperatively with other local agencies to manage the aforementioned groundwater basins in a sustainable fashion;

WHEREAS, adoption of this Resolution does not constitute a "Project" under the California Environmental Quality Act ("CEQA") pursuant to Sections 15378(a) and (b) of CEQA Guidelines, because this Resolution does not result in direct or indirect physical change in the environment; and

WHEREAS, notice of a public hearing to consider whether the City should elect to be a GSA, a copy of which is attached hereto as Exhibit "A," were published twice in the Firebaugh-Mendota Journal pursuant to section 6066 of the Government Code, as required by section 10723(b) of the Water Code; and

WHEREAS, courtesy copies of the hearing notice were sent to each of the Delta-Mendota Subbasin other potential GSAs, including the Boards of Supervisors of Stanislaus, Merced, Madera, and Fresno Counties, Patterson Irrigation District and West Stanislaus Irrigation District.

WHEREAS, the City held a public hearing at which the City Council considered whether the City should become the exclusive GSA for those portions of the Delta-Mendota Subbasin within the City's jurisdictional boundaries; and

WHEREAS, it would be in the best interest of the City to become a GSA for those portions of the Delta-Mendota Subbasin within the City's jurisdictional boundaries;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mendota as follows:

1. That the City hereby elects to be the exclusive Groundwater Sustainability Agency for those portions of the Delta-Mendota Subbasin that are within the City's jurisdictional boundaries, and as further depicted on the map attached hereto as Exhibit B, which is incorporated herein by this reference.

2. Within 30 days of the date of this Resolution, the Public Works Director or his designee is directed to submit a notice of the City's intent to the Department of Water Resources, pursuant to Section 10723.8(a) of the Water Code.

3. The Public Works Director or his designee shall, after complying with Water Code section 10727.8, begin the process of developing the City's Groundwater Sustainability Plan for the Basin in accordance with all applicable statutes and regulations.

4. The Public Works Director or his designee shall create and maintain a list of persons interested in receiving notices concerning the City's SGMA process pursuant to section 10723.4 of the Water Code.

5. The Public Works Director or his designee shall provide regular progress reports on the SGMA implementation process to the Council at least quarterly.



In December, Code Enforcement focused on water conservation, parking and other vehicle violations, shopping carts, and business license verification.

As part of our focus on the shopping cart issue, Code Enforcement hand-delivered a letter to each business that uses shopping carts, explaining to them their responsibility of ensuring their shopping carts remain on their property. It also explained that they need to call law enforcement if someone takes one of their carts off of the premises, and steps they need to take in order for law enforcement to take action when a cart has been removed from the premises without the knowledge of the owner. Staff will continue to follow up with businesses on this.

We continue to work with other departments for verifying business licenses, entitlements, and building permits, as well as with Fresno County to address issues just outside of our City Limits that affect our community.

Monthly Report for December 2016

Significant Cases:

Vandalism to a residence on Derrick. Owner discovered a broken window.

Officer hears gunshots and while responding to the area observes a vehicle leaving. Officer conducts a vehicle stop and is advised of a shooting victim on Stamoules. The occupants of the vehicle are detained and handguns are located. All are detained for investigation. All are eventually arrested for murder.

Subject check on Derrick discovered an open container of alcohol. He gave officers a false name, but his true ID was found out. He was arrested, cited and released.

Subject check at 8th/Oller found outstanding warrants. He was cited and released.

Non-injury traffic collision at Bass/Barbosa. The driver causing had a suspended license. He was cited and released.

Disturbance on Perez discovered the suspect hit the victim. He was arrested and transported to Jail.

Officers assisted CHP at the scene of a fatal traffic collision on Hwy 180 east of town. They detained the subject causing as he was attempting to flee the scene on foot. He was turned over to CHP officers.

Non-injury traffic collision at Juanita/Divisadero. Another vehicle collided with a city vehicle as it was turning.

Subject check on Stamoules found an outstanding warrant. He was arrested, cited and released.

Patrol check at the homeless camp on Bass resulted in an FI for information.

Report of shots fired at night in the area of 4th/I Street. Witness reports seeing a vehicle driving with no lights on. Suspects Unknown. No reported injuries or evidence.

Report of an intoxicated subject by Quince/7th Street. Officers located the subject who was intoxicated. He was arrested and transported to Jail.

Vehicle stop by Marie/9th discovered the driver was intoxicated. She was arrested for DUI and requested a blood draw. The contract phlebotomist responded and handled the blood draw. She also gave breath samples. She was cited and released to a sober adult.

An unknown subject stole a package from a residence's front porch.

Subject check by 6th/Rio Frio discovered active warrants. He was arrested, cited and released.

Subject urinating in public by 7th/Stamoules was found to be intoxicated. He was arrested and transported to Jail.

Officers were called to a residence on Lozano by an intoxicated person reporting he was chased by subjects. The incident was unfounded and the person remained in his residence. A short item later Officers were called to a residence around the corner regarding an intoxicated person claiming he was being chased. Officers discovered the same intoxicated person as prior. The caller did not want him there. He was found to be unable to care for himself and was arrested for public intoxication and transported to Jail.

Deceased person at a resident on Quince Street. EMS assisted and pronounced the victim deceased. Victim had a history of poor health and the death appears to be of natural causes. Coroner's Office responded.

Bicycle stop at 6th/Rio Frio discovered the rider was attempting to discard methamphetamine. He was arrested, cited and released.

Officer conducted a subject check in front of a trailer of a known parolee. Upon contact the subject said he was on probation. Officer located a concealed knife in his possession. Following the knife discovery, the parolee the Officer thought he was contacting exited the trailer while another unknown subject exited the trailer via a window and then fled on foot. Believing criminal activity was afoot the officer chased down the fleeing subject and detained him. Upon returning to the scene the probationer was gone, but the parolee who resides in the trailer was still present. A protective sweep of the trailer for additional subjects discovered methamphetamine and use paraphernalia in plain view. A rifle was also located. The parolee was found to have been discharged from parole, but was arrested for drug possession and being a former felon in possession of a firearm. The subject who fled on foot was arrested and volunteered for a blood draw. The contract phlebotomist responded. He was then cited and released. The former parolee was transported to Jail. The probationer was not located.

Threats on Tuft Street. The victim reported he was threatened by a known subject who was not present at the time.

Intoxicated subject sleeping in the parking lot of a restaurant on Derrick Street. Upon contact he was found to not be intoxicated, but a meth pipe was found in his possession. He was arrested and a check revealed he was on probation. He was cited and released.

Loud music on Garcia Street. Officers arrived and discovered persons were drinking, but not yet intoxicated. They were admonished regarding the music. Approx 30 minutes later officers returned and issued citations for Municipal Code violations and arrested one subject for public intoxication. He was cited and released to a sober family member.

Vehicle vandalism on Marie. Unknown suspect threw a rock through the windshield of the victim's vehicle.

Bicycle stop at 7th and Lolita discovered the rider was in possession of methamphetamine and a meth pipe. He was arrested, cited and released.

At the scene of the prior TC a citizen continued to attempt to contact the arrested subject after being admonished not to. Upon contact he was found to be intoxicated. He was arrested and transported to Jail.

Vehicle stop on Oller discovered the driver was intoxicated. He was arrested for DUI and while being processed his true identity was discovered. He admitted to lying to avoid officers discovering his CDL was suspended. He was transported to Jail

Unwanted subject at a residence on Quince. He was contacted and found to be intoxicated. He was unable to identify himself and was subsequently arrested. While in the police vehicle he attempted to kick out the rear windows. He continued to be uncooperative and was transported to Jail.

Subject check at Gomez/Gaxiola discovered the person was on probation for narcotic violations and auto theft. He was Fl'ed for information.

Vehicle stop at 4th/Oller Street discovered the driver was unlicensed and to have an active warrant. She was arrested, cited and released.

An unknown subject entered a local store on Oller and fled with a 12pk of beer without paying.

An known subject stole a cell phone from a residence on Jennings. The suspect was gone upon officers arriving.
