I believe the owner of the property is deceased and I am currently working on trying to locate a trustee or a bank who owns the property so we can have this matter resolved. As of now though we are keeping a close eye on it making sure and doing everything in our power to not let it become a bigger problem than what it is.

Also stated that he would like to run for council in the future and enjoys representing the City of Mendota on the Westside Mosquito Abatement District Board, the Catholic Church, and other organizations.

**Mike Lopez 748 Riofrio Street** - Acknowledged the work of Mayor Silva and Mayor Pro Tem Amador, pointed out the work that the Mayor has done to bring jobs to Mendota residents and supports Councilor Silva for Mayor.

Seeing no more members of the public wishing to comment, City Clerk Flood close the public comment portion and accepted nominations to serve as Mayor.

Councilor Valdez made a motion to nominate Councilor Silva as Mayor, seconded by Councilor Castro; unanimously approved. 5-0

Mayor Silva thanked the public for the support and talked about the duties of the office of Mayor.

b) Mayor Pro Tem

Mayor Silva accepted nominations to serve as Mayor Pro Tem.

A motion was made by Councilor Castro to nominate Councilor Valdez as Mayor Pro Tem, seconded by Mayor Silva. A motion was made by Councilor Riofrio to nominate Councilor Amador as Mayor Pro Tem.

Vote in the matter of Councilor Valdez serving as Mayor Pro Tem; unanimously approved (5 ayes).

Mayor Silva Introduced the item and Planning and Economic Development Manager Flood explained the surplus process; the discussion held at the previous meeting to explore the possibility of a private company doing the process in order to save money; and staff's results and recommendation to perform the surplus process in house.

Deputy City Clerk Cabrera gave a report on how the private companies would charge and what the process would be, including staff time that would still be required.

Discussion was held on the importance of ensuring that staff maximizes its time usage for this project.

A motion was made by Councilor Riofrio to adopt Resolution No. 14-46, seconded by Mayor Pro Tem Valdez; unanimously approved (5 ayes).

Planning and Economic Development Manager Flood reported that staff had received a request to use the community center to accommodate a visit from the Salvadoran Consulate; members of the Salvadoran community submitted the application on behalf of the consulate but requested that the City cover the cost for the liability insurance as it will provide a benefit to many members of the community.

**Flor Larreynaga (201 Espinoza Street)** - Reported on contact they had with the office of the Consulate and the hardship that people face in paying someone to take them to San Francisco, just to get in a line and not be seen.

Discussion was held on requiring the residents to pay the 107.40 insurance fee; that it has been 7 years since the Salvadoran Consulate has come to Mendota; the amount charged to give a ride to a Mendota resident to the Consulate in San Francisco or Los Angeles.

**Liberty Lopez (RCS)** - reported that her organization can possibly cover the insurance.

A motion was made by Mayor Pro Tem Valdez to adopt Resolution No.14-49, seconded by Councilor Amador; unanimously approved (5 ayes).



**SUBJECT:** DISCUSSION ITEM – DERRICK/OLLER ROUNDABOUT

**DATE:** JANUARY 13, 2015

## **BACKGROUND**

At the City Council meeting on December 9, 2014, the City Council approved contracts with contract city engineer Provost & Pritchard for various engineering activities pertaining to the roundabout improvement planned for the Oller/Derrick intersections. Since that time, members of the City Council have expressed concern as to whether a roundabout is the appropriate traffic control/management solution for that intersection.

On January 8, 2015, the Mayor and City Manager met with Caltrans staff to discuss the City's concern. As a result of that meeting, Caltrans recommended that the City of Mendota authorize Provost & Pritchard to begin the traffic study at this time. Once the traffic study is completed, the data will be used by Caltrans to create an animated model to present to the City Council at a future meeting that demonstrates how the current and future projected volume of traffic would actually move through the roundabout. Additionally, models showing conventional intersection improvements, i.e., signalization, will also be presented to Council.

#### **ANALYSIS**

Due to the fact that the intersection improvements at Oller and Derrick will be a Caltrans owned and operated facility, Caltrans can, without the City's permission, install whatever type of improvements they deem appropriate. However, Caltrans staff made it clear that they will consider the Council's opinion regarding whether the intersection should be regulated with a roundabout or a signal prior to making a final decision.

The key considerations at this juncture are to preserve the majority of the project's funding, while also ensuring that the Council is comfortable with the Caltrans decision on the intersection's improvement.

## FISCAL IMPACT

The project has a budget of \$1.8 million. The majority of the funds will come from FCTA funding set aside for Derrick Avenue Corridor improvements and another component will be grant funding. There will be no impact to the General Fund. If the roundabout solution is scrapped, the City will need to return to the FCTA and request that funds allocated specifically for the roundabout project be used for an alternative traffic management/control solution. It is also likely that the grant funding will be lost if the roundabout alternative is discarded.

## **RECOMMENDATION**

Staff recommends that the City Council provide direction to: 1) authorize only the portion of the previously approved contracts that permit the conducting of the traffic study be initiated and delay implementation of the other major portions of the previously approved contracts with Provost & Pritchard, and 2) direct the city engineer to work with Caltrans to prepare a range of intersection control alternatives based on data obtained from the traffic study for discussion at a future City Council meeting.

**SUBJECT:** DISCUSSION OF THE ISSUE OF PERMITTING OFF-SITE SIGNS.

**DATE:** JANUARY 13, 2015

## **BACKGROUND**

City staff has received inquiries regarding the current Zoning Ordinance prohibition against off-site signs. An off-site sign is a sign advertising a specific business, or various elements of a specific business, that *is not* located on the same site as the business it represents. It is exceedingly common, almost universal, for cities to prohibit off-site signage due to the fact that if allowed, they would lead to a propagation of lower quality signs and contribute to an overall poor aesthetic throughout the community.

Two businesses, Di Amici's and Farmer's Insurance, have raised issues relative to the prohibition of off-site signs. Both businesses recently received citations for their off-site signs. The issue is being presented to the Council for discussion purposes to elicit whether the Council would consider entertaining any type of off-site signage regulations. Typically, if the Council were inclined to examine this issue with an eye toward a possible zoning ordinance amendment, it would be appropriate for Council to send the issue to the Planning Commission for further review, with the Planning Commission forwarding their recommendation to the Council at a future meeting.

#### **ANALYSIS**

Section 17.44.050 K., of the Zoning Ordinance addresses the issue of signs. The section deals entirely with on-site signage – signage relating to a use or business on the same site as the business itself. The ordinance prohibits off-site signage by omission – meaning that the zoning ordinance is silent on the issue, and as such, the use is prohibited.

There are several reasons why it is a standard urban planning and zoning ordinance practice to prohibit off-site signage. First, off site signs are typically of a lower quality than an on-site sign and contribute to a negative community aesthetic, (the off-site sign advertising Di Amici's Coffee Shop that can be seen at the entrance to the City at Oller and Belmont is already noticeably deteriorating). Secondly, if allowed, off-site signs would soon proliferate across the city advertising businesses on virtually any vacant parcel and also contribute to a less than desirable community appearance. Third, off-site signs would be a regulatory ordeal for staff, with problematic issues such as content,

materials, size, color, location – all factors which would be virtually impossible to fairly administer.

While the Council may choose to send this issue to the Planning Commission for further analysis and recommendation, it is likely that both the Planning Commission and Council will find that the overwhelming majority of cities have an outright prohibition on off-site signs for the reasons noted above.

## **FISCAL IMPACT**

There is no known fiscal impact associated with this issue.

## **RECOMMENDATION**

Staff recommends that the City Council take no action on this issue, leaving the current regulations in place.

SUBJECT: FRESNO COUNCIL OF GOVERNMENTS "ONE-VOICE" INITIATIVE

## **BACKGROUND**

For the last several years, the Fresno Council of Governments (COG) have formed a delegation of representatives from Fresno County cities, (typically the Mayor and City Manager), to travel to Washington, DC, to meet directly with members of Congress to discuss federal funding initiatives that are vital to the County and City.

This year the "One-Voice" trip will be April 11-16, 2015. Mayor Silva and I are tentatively planning to attend as part of the Fresno County delegation. As this is a non-budgeted item, I am currently in contact with a number of larger companies that do business in or around Mendota requesting a contribution to fund the Mendota delegation. It is estimated that the trip, including travel, lodging, and meals will be cost \$4,300. First Solar, Westlands Water, and Mid Valley Disposal are all considering a contribution to assist in funding the trip. I anticipate hearing from them later this month.

This agenda item is for Council to discuss and provide direction on initiatives that will/may benefit the City of Mendota. Council's direction will be represented by the City Manager at a COG meeting on this issue on January 15.

## **FISCAL IMPACT**

Assuming no business contributions are received, the cost of the trip will come from the General Fund and a budget amendment may be necessary in the future to properly appropriate the funds.

## **RECOMMENDATION**

At this time, Council should provide direction to staff on initiatives that should be discussed that would benefit the City of Mendota and direct staff to represent same at the COG meeting on January 15.

## Significant cases:

During the month of December the Department participated in the countywide Drunk Driving Strike Force. This is a grant program funded by the Office of Traffic Safety. Over the holiday period the officers logged over 78 hours and made 5 DUI arrests, and made 13 other driving related arrests as part of the Drunk Driving Strike Force.

A Grinch Christmas. On 12-1-2014 the resident at 475 Kate St was awoken with the noise of dogs barking. The resident looked outside and found someone had stolen his blow up Tyrannosaurus Rex Christmas ornament.

Officers were dispatched to 749 Quince Street regarding an unwanted subject. The resident stated a subject has been staying on her property unlawfully and refuses to leave the premises. Officers contacted the suspect who immediately became aggressive and charged at officers with a metal pole. The subject was given multiple commands to drop the metal pole but refused to comply with the commands and was subsequently tased. After a short struggle, the subject was successfully placed under arrest and evaluated by EMS for the taser applications. The subject was the same subject who assaulted officers with a machete at 624 Quince Street last month. Due to Portillo's aggressive nature, the Department of Immigration and Custom Enforcement was contacted regarding the incident and authorized an INS Detainer on subject. The subject was processed and transported to Fresno County Jail.

Officers were dispatched to the entrance of the Fastrip Store located at 9<sup>th</sup> St. and Oller St. due to the male causing a verbal disturbance. During the contact the male advised the officer he did not have a driver's license as he was pumping gas into a white colored Lexus. The male got into the driver seat of the Lexus and disobeyed the officer's orders. The male ignored the officer and sped off in the Lexus. A short pursuit ensued and officers lost sight of the Lexus due to the high rate of speed. Short time later officers located the white Lexus at the alleyway of 1782 4<sup>th</sup> St. The Lexus had collided into a rail barrier at the end of the alley way and the driver was nowhere to be seen. Officers canvassed the area and were contacted by a resident who advised a male had tried to climb through the back window of his house. The description of the male given by the resident fit the description of the suspect. Officers continued to canvas the area in search of the suspect who was not located. At 0330 hours an employee from the Fastrip Store contacted dispatch and advised the subject who officers were involved in the original incident had returned to the store. Officers arrived on scene and arrested the suspect. The suspect was also found to be in possession of a meth pipe. The suspect was positively identified through the Fastrip cameras and by eyewitnesses. The suspect was later was transported to FCJ where he was booked.

Officers were dispatched to 1187 Oller for a report of a deceased person. Upon arrival Officers contacted CAL Fire who stated the decedent was obviously dead and no life saving measures were taken. Officers and Fresno County Coroner were unable to make a positive ID of the descendant on scene. The Autopsy revealed the subject passed away from natural causes.

On 12-22-14 Officers contacted a subject check who is known to be on probation and is a known car thief near Canal St. and 9<sup>th</sup> St. During a probation search of the subject he was found to be in possession of 4 shaved car keys. The subject's probation officer was contacted and a probation violation hold was placed on the Subject and he was booked into FCJ.

One for the books. On 12-19-14 officers were flagged down by a subject who appeared to be intoxicated at 7th and Oller. The subject told the officer he wanted to go to jail. While talking to the subject, he took a combative stance and his wish was answered and was taken into custody for public intoxication.

**Merry Christmas** Mendota Police Officers gave away 10 bikes to needy families during the holiday. These bikes were abandoned and then refurbished with the assistance of the Corcoran state prison inmates.

# **Departmental Strategic Planning:**

In an effort to increase the department's efficiency and leadership training we are sending our department supervisors to other agencies to shadow their counter parts. It is hoped this will increase efficiency, develop new skills and hopefully bring new ideas and solutions through the collaborative effort. This will begin after the first of year.

Collateral duties within the department have been identified and assignments given. The assignments include Range, Scheduling, IT, Evidence Room, Reserves, Explorers, Training, and Equipment.

To increase department accountability through communication we will be conducting staff meeting on a minimum of once a month. Agenda's will include collateral duty assignments, strategic planning and the department's goals and objectives.

SUBJECT: CITY MANAGER'S REPORT – END OF THE YEAR REVIEW

**DATE:** JANUARY 13, 2015

Over the course of the last nine months, since the appointment of a new city manager, several key organizational changes and processes have been implemented that have Mendota moving in a decidedly more positive direction. This report provides a summary – a year in review if you will – of some of the new initiatives, designed to implement the overall Council goals.

## **Economic Development**

In process at this time is the Derrick/Belmont commercial development, which currently consists of a McDonald's, an AutoZone, and four other undefined parcels (one if which is suited for a larger scale commercial tenant). Staff is currently processing a parcel map (the formal land division process that creates the legal parcels of record), and following that approval, site plan reviews for the specific tenants are anticipated to follow. This project represents the largest single economic development project that Mendota has ever seen and will no doubt significantly enhance sales tax revenues.

With a promotion earlier in the year, City Clerk Matt Flood, assumed the additional role of Planning and Economic Development Director. As part of his new responsibilities, Mr. Flood is preparing the City's first Economic Development Plan which will identify key properties, along with possible development incentives and outreach strategies, that will seek to attract even more new businesses to Mendota.

#### Public Works

The most challenging aspect of the City's Public Works function is to continue to maintain the City's parks and make necessary street improvements with limited staff resources. Nevertheless, using a combination of Measure C funds, LTF funds, and impact fees (where appropriate), the Public Works Director in conjunction with the City Manager, have outlined a five-year road improvement plan that will reconstruct and/or improve the majority of streets in the downtown areas of the City.

Additionally, improvements made to Rojas-Pierce Park over the last nine-months include additional shade structures with seating and barbeque areas, along with additional landscape improvements.

#### **Public Utilities**

Since the division of the larger Public Works Department into the Public Utilities and Public Works departments was made in 2013, staff has discovered numerous shortcomings in the management of the City's water treatment and wastewater treatment facilities. These included damage to certain components of the City's water treatment system, deferred maintenance of key components of the water and sewer systems, and the failure to submit State required administrative documents. In July 2014, Matt Lewis was hired as the City's new Public Utilities Director, and through his efforts and management skills, not only has staff been able to remedy the shortcomings in our State reporting requirements, but improvements to the water treatment system are nearing completion and a regular maintenance program to both water and sewer systems have been established. Through the budget process, staff will recommend to Council continued investment in these systems, but it is clear that we've "turned the corner" and are proceeding in a much better direction.

## Police

The Council has clearly communicated to the City Manager their goals for how they feel the public safety function should be administered. To that end, the City Manager is committed to the implementation of a true "community oriented policing" philosophy from the City's police department. Nationwide we have seen time and again police departments play the role of a paramilitary occupation force. In your City Manager's opinion, this is <u>not</u> the correct approach for Mendota. With the retirement of Chief Galvin and recruitment efforts underway for a new police chief, your City Manager will ensure that the candidate selected will not only understand the Council and Manager's expectations with regard to a "community policing" approach, but will have the skills necessary to implement that approach and reach out to the community in a positive and proactive way.

Your City Manager also feels that the pay scale for the Police Department requires restructuring in order to be competitive with similarly situated departments in the area. This will require some innovative and responsible budgetary solutions. Strategies to this end will be submitted to Council in the coming months.

### Additional Initiatives

Over the course of 2014 some additional incentives have also been undertaken and are currently in process with the final results scheduled to be concluded later in 2015. These include:

• Impact fee update – approved by Council and underway currently by Provost & Pritchard (In progress)

- The retention of a grant consultant approved by Council, with one grant application having been submitted, and two additional applications currently underway (On-going).
- The initiation of discussions with the California Public Employees Retirement System (Cal PERS) with an eye towards bringing PERS to the City as the employee retirement plan. (In progress)
- Initiating a partnership with the California State University, Fresno, Department of Community and Economic Development and the California Coalition for Rural Housing for a grant to update the City's municipal code. (In progress)
- Examination of a City-wide lighting improvement project utilizing OBF (on-bill financing) (In progress first phase in January/February 2015).
- Preliminary discussions with solar field developers for a solar panel project at the wastewater treatment plant (In-progress).

Overall, 2014 has been a very positive year for new initiatives in the City of Mendota. While the local economy continues to struggle, staff continues to pursue avenues to implement the Council goals and policies and provide for an improved quality of life for Mendota residents.
