A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA REJECTING BIDS FOR THE CDBG MENDOTA WATER SYSTEM IMPROVEMENTS PROJECT NO. 15-471 **RESOLUTION 16-68**

WHEREAS, the City of Mendota applied and received funding from Fresno County through the Community Development Block Grant (CDBG) program for construction of two metal buildings to protect the water treatment equipment and piping otherwise known as Project No. 15471 (the "Project"); and

WHEREAS, the Project was publicly advertised for the second time and modifications were made to the project scope and bid structure to eliminate fiscal constraints to the City; and

WHEREAS, the City received two bids, one from Hobbs Construction in the amount of \$357,792 and a second bid from Dovali Construction in the amount of \$446,300. The lowest bid (Hobbs) was found to be in order but was substantially greater than the grant funding available and what the City budgeted for; and

WHEREAS, due to the aforementioned amount of \$357,792 being more than what the City intended to fund staff recommends for the City Council to reject the bid: and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Mendota authorize the City Manager to reject the bid from Hobbs Construction for the construction of two metal buildings at the Mendota Water Treatment Plant.

SUBJECT: Delegation of Authority to Reject Certain Claims Filed Pursuant to Government

Code Section 810, et seq.

RECOMMENDATION:

Approve Resolution No. 16-71, delegating authority to the City Manager to reject certain claims presented to the City under Government Code Section 810, *et seq.*

BACKGROUND:

The California Tort Claims Act, Government Code, Section 810, *et seq.* (the "Act") provides certain procedures under which any person or entity may present claims for damages against local agencies, including the City of Mendota. The Act, among other things, limits the amount of time within which persons or entities may seek tort damages against the City. For instance, the Act requires that certain claims must be presented to the City on or before six months to one year after the cause of action accrues, depending on the nature of the injury. (Govt. Code, § 911.2.)

The Act, however, also imposes certain requirements on the City. For instance, to receive certain benefits provided under the Act, the City must consider claims presented to the City within 45-days. (See Govt. Code., § 912.4.)

The City is presented with claims under the Act from time-to-time. Many of these claims seek minimal damages and/or can be turned over to the City's carriers for resolution. It would also be unduly burdensome on both City Staff and the City Council to present all such claims to the City Council for resolution within the 45-days provided under the Act, as the evaluation of many such claims would require discussion with counsel in closed session in advance of any action by the City Council on the claim.

However, City Staff does believe that certain claims are appropriate for consideration by the City Council. For example, if City Staff recommends allowance or conditional allowance of a claim, City Staff believes such decision should be made by the City Council. The same is true for claims seeking significant damages from the City.

DISCUSSION:

Based on the foregoing, City Staff recommends the adoption of a resolution under which the City Manager would be delegated the authority, working in conjunction with the City Attorney, to reject claims presented to the City pursuant to the Act in the amount of \$100,000 or less. Claims of \$100,001 or greater would be presents to the City Council. Moreover, in the event City Staff recommends the allowance or conditional allowance of a claim, such claims would also be presented to the City Council.

ISSUE

Should the Council introduce Ordinance No. 16-09 and waive its first reading in full?

BACKGROUND

The applicant proposes to amend the planned land use for an existing legal lot northeast of McCabe and Sorensen Avenues the site from Medium Density Residential to High Density Residential, rezone the entirety of the property to R-3, and subdivide it into two lots. On September 20, 2016, the Planning Commission adopted Resolution No. PC 16-05, recommending in part that the City Council approve the rezoning of the site. The remaining components (CEQA consideration, general plan amendment and tentative parcel map) will be brought to the Council for consideration at its October 25, 2016 meeting.

ANALYSIS


The site currently contains three distinct zone districts: R-1, R-3, and C-3 (see exhibit). Ordinance No. 16-09 would rezone the entirety of the property to the R-3 High Density Multiple-Family Residential zone. The new zoning could ultimately support a variety of higher-density housing options, although no development is proposed at this time. In order for the rezoning to take effect, the Council would need to approve the proposed amendment to the General Plan at a future hearing.

FISCAL IMPACT

There would be no impact to City funds. Costs associated with application processing are typically borne by the applicant. If the site eventually develops, the City would collect impact fees to fund capital improvements.

RECOMMENDATION

Staff recommends that the City Council introduces Ordinance No. 16-09 and waive its first reading, and set a public hearing date for second reading and adoption to occur its regular meeting of October 25, 2016.



In September, Code Enforcement continued to focus on water conservation, vehicle related issues, including parking violations and abandoned vehicles, and violations related to building permits.

As stated in last month's report, water conservation will continue to be a focus (even as the weather cools down) due to the threat of fines from the State of California. Many people continue to have automated systems that waste water, run on a day that is not their assigned watering day, or run at inappropriate times. While this is uncomfortable for some residents, we continue to educate them by explaining that water is a public resource that must be used responsibly, and that they do not pay for the water, but pay for the acquisition and delivery of it.

Staff has met with a few parties regarding a lack of compliance with Conditional Use Permits (or other entitlement) conditions, and will continue to do so as many of the improvements required by those conditions have to do with health, safety, and beautification.

We ask that everyone continue to advertise the Code Enforcement Tip Line (559) 517-6340 so that people can report any issues they have anonymously and can have their issue taken care of in an expedient manner.
