

FIRST AMENDMENT TO EMPLOYMENT AGREEMENT

WHEREAS, The City of Mendota ("City") has employed Vince DiMaggio ("Employee") as City Manager and entered into an Employment Agreement, effective April 21, 2014; and WHEREAS, the CITY and EMPLOYEE wish to amend the Employment Agreement.

Now, therefore, in consideration of the mutual covenants herein contained, effective October 21, 2014, the parties agree to amend the Employment Agreement as follows:

1. Section 2. COMPENSATION AND TERM OF SERVICE

Paragraph C. Severance Benefits:

"three (3)" shall be deleted and "twelve (12)" shall be put in its place throughout this paragraph.

2. Section 3. SUPPLEMENTAL BENEFITS

Paragraph C. <u>Administrative Leave</u>:

"48" shall be deleted and "80" shall be put in its place, and "1.84 hours per pay period" shall be deleted and "6.67 hours per month" shall be put in its place, retroactive to April 21, 2014.

Paragraph H. Monthly Vehicle Allowance:

"\$300.00" shall be deleted and "\$500.00" shall be put in its place.

3. In all other respects, the Employment Agreement, as amended, shall remain in full force and effect.
