# MINUTES OF MENDOTA SPECIAL CITY COUNCIL MEETING

Special Meeting November 13, 2015

Meeting called to order by Mayor Silva at 12:00 p.m.

**Roll Call** 

Council Members Present: Mayor Robert Silva, Councilors Joseph Amador,

Rolando Castro, and Joseph Riofrio.

Council Members Absent: Mayor Pro Tem Valdez.

Flag salute led by Councilor Riofrio in honor of the men and women serving in the armed forces.

#### **FINALIZE THE AGENDA**

- 2. Adoption of final Agenda.

A motion was made by Councilor Riofrio to adopt the agenda, seconded by Councilor Amador; unanimously approved (4 ayes, absent: Valdez).

#### CITIZENS ORAL AND WRITTEN PRESENTATIONS

#### NOTICE OF WAIVING OF READING

1. Notice of waiving of the reading of all resolutions and/or ordinances introduced and/or adopted under this agenda.

Consensus was reached to approve item 1.

#### **BUSINESS**

 Council discussion and consideration to adopt Resolution No. 15-78, approving the conversion from Aetna PPO to Blue Shield PPO health care plan.

Mayor Silva introduced the item and Director of Administrative Services Johnson reported that a workshop was held on November 12<sup>th</sup> for employees to discuss the conversion from Aetna PPO to Blue Shield PPO and how the conversion would affect them; a confidential memorandum that the City issued each employee that contains information about their new premium rate and the cap level amount; new insurance cards being issued to employees; and a majority of employees being in favor of the conversion.

Discussion was held on the majority of employees being in favor of the conversion; some members of the MPOA having concerns about Blue Shield PPO such as the increase of their deductible rate; the City saving approximately \$36,000 per year as a result of the conversion; other insurance brokers that may be able to offer the City lower insurance rates; and the ongoing gradual increase of health care premiums.

**Debbie Macias (Business Agent for AFSCME)** – stated that she has received positive feedback from union members in regards to the conversion and reported that the general employee union is fortunate to benefit from the conversion.

A motion was made to adopt Resolution No.15-78 by Councilor Riofrio, seconded by Mayor Silva; approved (3 ayes, no: Castro, absent: Valdez).

Discussion was held on staff researching insurance brokers that will provide the City with better health insurance rates and the City working with the City's current health insurance broker since due to the personalized and quick response the City receives.

#### **ADJOURNMENT**

With no more business to be brought before the Council, a motion for adjournment was made at 12:15 p.m. by Councilor Amador, seconded by Councilor Riofrio; unanimously approved (4 ayes, absent: Valdez).

Discussion was held on the individuals from various religious organizations that have given the invocation at the City Council meetings.

A motion was made to approve items 1 and 2 of the consent calendar by Councilor Amador, seconded by Councilor Riofrio; unanimously approved (5 ayes).

3. Council authorize the City Manager and the City Attorney to execute a lease agreement with Mendota Youth Recreation.

Mayor Pro Tem Valdez stated that he would abstain from voting on the item, stepped down from the dais, and joined the audience at 6:11 p.m.

**Sergio Valdez (Mendota Youth Recreation [MYR])** – requested that the lease be extended for an additional five years.

Discussion was held on MYR paying the electricity bill for the building; the lease being extended for an additional five years; and Council requested that MYR's rent be paid in full.

A motion was made to approve item 3 of the consent calendar with the modification of the lease agreement to be extended for an additional five years by Councilor Riofrio, seconded by Councilor Amador, approved (4 ayes, abstain: Valdez). Mr. Valdez paid the total amount owed to the City for the lease of the building at 667 Quince Street for the period included in the adopted lease agreement (for a total of seven dollars) to Finance Administrative Supervisor Diaz.

At 6:16 p.m. Mayor Pro Tem Valdez returned to the dais.

City Manager DiMaggio reported that he will be out of the office for the rest of the week and will return next week.

Discussion was held on a meeting that was held with various organizations to discuss how to minimize the effects of El Niño and future flooding issues in Mendota and the City being the second city in Fresno County to hold such a meeting; a meeting that was held with City Department Heads in regards to the City's response strategy plan should a significant weather event occur; the City having to mitigate the impacts that will result from a rainstorm; the importance of having a proactive response to El Niño; the response from the Fresno County Board of Supervisors in regards to the bill that the City submitted to them for the costs acquired from the July flash flood; the benefits of collaborating with other organizations to minimize the effects of El Niño; the status of the City-wide lighting retrofit; the status of City crews installing Christmas decorations throughout the City; and removing the baseball nets that are at the Benny Mares Sr. baseball field.

Discussion was held on staff contacting the VFW in regards as to the City taking over the installment of the flags for designated holidays.

Councilor Riofrio inquired as to how Mendota Police Officers are scheduled to work for the holiday season; reported on new homeless encampments within and surrounding the City; and the reported on the upcoming semi-final high school football game between the Mendota Aztecs and the Dos Palos Broncos.

Discussion was held on the new homeless encampments within and surrounding the City.

Councilor Amador reported on the Joint Powers Agreement between the Westside Cable Authority and Comcast being dissolved.

Discussion was held on the reimbursement checks being sent out to various Cities and out-of-town businesses no longer delivering to stores within Mendota since they do not want to purchase a City Business License.

Mayor Pro Tem Valdez reported on the Annual Senior Thanksgiving Luncheon that was recently held and inquired as to the possibility of displaying historical pictures of Mendota at the Mendota Branch Library.

### 2. Mayor

Mayor Silva commended Mendota Youth Recreation and volunteers for their hard work before and during the Annual Senior Thanksgiving Luncheon and reported on other counties approving Mr. Mario Santoyo's joint powers agreement plan.

Discussion was held on the upcoming Annual Christmas Parade and the City being required to be part of a jpa in order to receive Proposition 1 funding for water storage projects.

**SUBJECT:** PARTICIPATION IN THE FEDERAL SURPLUS PROPERTY PROGRAM

**DATE:** DECEMBER 8, 2015

#### **ISSUE:**

Should the City Council allow the Police Department to participate in the Federal Government Surplus program (1033)?

#### **BACKGROUND:**

The Federal Government declares large amounts of government property as surplus on a regular basis. These items are then available for procurement by eligible recipients. Local governments have been deemed appropriate recipients for the surplus property. In California, the Federal Surplus Property Program has benefited many municipal and county governments by supplying then with needed equipment resources.

#### **DISCUSSION:**

These surplus items are obtained from all the major departments of the Federal Government including Defense, Interior and Homeland Security. The condition of the items range from good to poor and the recipients can inspect the property prior to accepting the item.

To be eligible to receive surplus property under this program the City Council must pass a resolution authorizing the City's participation. There may be fees associated with acquisition of the item. Said fee amount will be made available prior acceptance of an item so withdrawing interest in the item is an option.

#### **FISCAL IMPACT:**

The Federal Surplus Property Program may require a fee to accept an item. Fee amounts vary among items on a case by case basis.

#### **RECOMMENDATION:**

Staff recommends that the Council adopt Resolution No. 15-84, approving the participation in the Federal Surplus Property Program.

#### **STREETS AND ROADS**

• The City's street sweeper continues to operate on its normal schedule, Mondays, Wednesdays and Fridays.

- Construction on Quince Street between 8th to 10th Streets is near completion. New pavement has been installed and striping is to follow.
- Staff hosted an emergency preparation meeting with local agencies and stakeholders to discuss flood and emergency preparation and coordination. Valuable information was exchanged by the attendees.
- Holiday decorations are being installed, along with the Christmas Tree at the intersection median on Oller and Derrick (180 and 33).
- ATP (Active Transportation Plan) awarded the City funds to install a cross walk system, sidewalk and a median at the intersection of Bass and Second Streets. Work is to take place shortly.
- The LED street and park light retrofit is set to begin in mid December. This project will include the replacement of all non efficient street light fixtures (not poles) City wide with LED high efficient fixtures. A few years ago a section of the City's street lights were retrofitted and now, with this project, all lights will be retrofitted creating energy savings.

In November the Code Enforcement Department focused on ensuring that people do not camp or otherwise live in open spaces or abandoned housing, especially due to the evictions carried out on Westlands Water District's property. Near the end of November we have been communicating frequently with other agencies, including the operators of the railroad and Fresno County, informing them promptly of individuals and groups illegally inhabiting properties they own or have jurisdiction over.

Also of focus have been preventing other public nuisances, littering/illegal dumping, and vehicle related violations, including RV's, campers, and boats that are illegally stored in residential zones. The last issue (contained in MMC § 17.88.010(A)(9)(a)(vi)) has been a topic recently as we have informed property owners illegally storing these vehicles that they need to be moved to an appropriate place or risk the forced removal of them via our public nuisance abatement process. There is no type of exception to this law and the only way to store such vehicles in a residential zone is to have them behind a solid fence or wall in their backyard or in a completely enclosed area.

Also of note is that Code Enforcement Officers continue to find people in violation of the water conservation measures. While this is unusual given the time of year, we will continue to monitor this in order to help instill a habit of conserving water in the community.

In December Code Enforcement will continue to focus on trespassers/illegal tenants within the City, and illegal modifications to homes that result in people living in garages or other spaces not suitable for human habitation.
