SUBJECT: REPORT ON ACHIEVEMENT OF 2015 GOALS AND INTRODUCTION OF 2016

STAFF GOALS

DATE: FEBRUARY 2, 2016

BACKGROUND

Last year, the staff and City Council held a special meeting to identify goals for the 2015 calendar year. I'm pleased to report that out of the 11 goals identified by staff for 2015, 8 were fully implemented. Of the remaining three, one requires perpetual attention (Westside cities working together), another requires a response from a state agency out of the control of City staff (PERS), and the third requires substantial funding for engineering that has yet to be identified (storm drain system). However, all goals that were not dependent on outside involvement were successfully achieved.

In the same meeting, Council identified four additional goals (see attached). Time, staffing, and funding all played a role in the progress made on those goals. While staff was able to make progress toward identifying new water sources through examining and acting on various Proposition 1 grants that would allow for both studies and exploratory wells, it is currently unknown as to whether the City will be awarded those grants. Regarding the goal of identifying alternative airport uses, staff did make progress holding two separate meetings with the FAA, from which it was learned that converting the airport would require the re-payment of federal funding that has been received over many years – approximately \$200,000. Once this was identified, work slowed on this goal, because its attainment became both unlikely and infeasible.

Little progress was made on identifying opportunities for an industrial business park for several reasons. First, the logical location for such a land use is the airport and the information received from the FAA made its conversion cost prohibitive – at least at this point. Second, staff has focused on implementing the related goal of enhancing commercial economic development through implementation of the economic incentive zone – which has been very successful. Third, there have been very few inquiries about industrial uses wanting to locate in Mendota.

2016 GOALS

Below is a chart with the City Manager's proposed goals for 2016. These goals are offered for discussion purposes as part of the Goal Setting meeting. Each goal is ranked in terms of its priority from 1 (most important) to 5 (least important). Most high ranking goals proposed for the new year continue to emphasize efforts to expand a revenue base (see Goals 3 and 6). A number of goals with a priority level 2 also can potentially positively affect revenues (see Goals 5 and 11).

CONCLUSION

While not included in the list of goals above, it is recommended that a goal directing the City Manager to reduce healthcare costs be considered by the Council. The unorthodox practice of having city-paid premiums for all subscription levels combined with substantial premium increases annually is having a demonstrably negative impact on the budget – see the 2015 audit, where rising healthcare costs were mentioned several times by the auditors as having an adverse impact on city finances. The City Manager will speak directly to healthcare costs during the oral report.

Lastly, please keep in mind our limited staff resources during the discussion of additional goals beyond those suggested above. As City Manager, my personal performance goals is to deliver a similar report to Council next year, which shows the overwhelming number of goals were actually achieved.
