During the month of April the Code Enforcement Department has been focusing on weed abatements, water conservation code, public nuisances, and violations related to vehicles, such as abandoned or non-operative vehicles in the street (or in public view on their property), and vehicles parked where they are not supposed to be, such as in their yard.

Code Enforcement staff has begun citing water violations according to MMC 13.32.070, which directs staff to apply fines to a resident's water bill:

First Violation - Written notice.

Second Violation - Written notice and \$15.00 penalty.

Third Violation - Written notice and \$25.00 penalty.

Fourth Violation - Written notice and \$50.00 penalty.

Fifth and Subsequent Violations - Written notice, \$50.00 penalty and the possibility of "a flow restrictor placed in their service until such time that they can assure that no more waste will occur. All costs, including overhead, for this installation shall be billed to the customer."

Mayor Silva introduced the item and City Manager DiMaggio summarized the report.

At 6:21 p.m. Mayor Silva opened the hearing to the public and, seeing no one present willing to comment, closed it in that same minute.

Discussion was held on instances in the past when an individual received the proper certification to sell goods out of their home; the enforcement of cottage food operations; and Cathy Baker, an individual who was the first person to apply for a Cottage Food



Operation permit.

A motion was made to adopt Ordinance No. 15-04 by Mayor Pro Tem Valdez, seconded by Councilor Riofrio; unanimously approved (5 ayes).

2. Council hold a public hearing and perform the second reading of **Ordinance No. 15-05**, establishing Chapter 17.81 the Economic Incentive Zone Overlay District by amending Title 17 of the Mendota Municipal Code.

Mayor Silva introduced the item and City Manager DiMaggio summarized the report.

Discussion was held on the possibility of amending the parcels within the Economic Incentive Zone (EIZ) and the businesses interested in the EIZ.

At 6:33 p.m. Mayor Silva opened the hearing to the public.

Ramiro Expinoza (837 Stamoules)- stated that he is speaking on behalf of the Chamber of Commerce; the positivity that the EIZ will bring to the business community; and asked about the residential zoned properties within the EIZ.

At 6:35 p.m. Mayor Silva closed the hearing to the public (At 6:35 p.m. Councilor Amador left the Council Chambers).

Discussion was held on the various incentives included within the EIZ(At 6:37 Councilor Amador returned to the Council Chambers).

Mayor Silva introduced the item and Chief of Police Andreotti summarized the report including the clarification of Reserve Officer designation.

A motion was made to adopt Ordinance No. 15-06 by Mayor Pro Tem Amador, seconded by Councilor Riofrio; unanimously approved (5 ayes).

## **SECOND AMENDMENT TO EMPLOYMENT AGREEMENT**

WHEREAS, the City of Mendota (“CITY”) has employed Vince DiMaggio (“EMPLOYEE”) as City Manager and entered into an Employment Agreement, effective April 21, 2014; which was later amended effective October 21, 2014 and

WHEREAS, the CITY and EMPLOYEE wish to further amend the Employment Agreement.

Now, therefore, in consideration of the mutual covenants herein contained, effective May 12, 2015, the parties agree to further amend the Employment Agreement as follows:

### **1. Section 2. COMPENSATION AND TERMS OF SERVICE**

Paragraph A. Compensation - the following shall be added to the end of the paragraph:

“Effective May 12, 2015, EMPLOYEE’S base salary shall be \$121,000/year. Effective January 1, 2016, EMPLOYEE’S base salary shall be \$129,000/year. Effective July 1, 2016, EMPLOYEE’S base salary shall be \$137,000. The CITY may consider additional increases to base salary as part of EMPLOYEE’S annual evaluation.”

### **2. Section 3. SUPPLEMENTAL BENEFITS**

Paragraph H. Monthly Vehicle Allowance – the first sentence of the paragraph is hereby deleted and replaced with:

“CITY shall provide EMPLOYEE with a city-owned vehicle for all work and business-related travel, in accordance with City Council Resolutions 13-18 and 14-13. EMPLOYEE is responsible for all fuel-related costs for commuting to and from work.”



3. In all other respects, the Employment Agreement, as amended, shall remain in full force and effect.

# Mendota Police Department Memorandum

## **Significant Cases:**

Attempt traffic stop in the area of 6th Street and Stamoules. The vehicle record came back to a 2007 Toyota, but it was not. The vehicle failed to yield, but travelled to the parking lot of Mendota PD where it stopped. The driver was taken into custody w/o further incident. The driver was processed and transported to Jail.

A male subject was stopped at 8th and Oller for a vehicle code violation while riding a bicycle. He was found to be in possession of 2 grams of methamphetamine. He was processed at MPD, cited and released.

A male subject was contacted in the 1000 block of 2nd Street. He was found to have 4 outstanding misdemeanor warrants for drug offenses. His ID was confirmed via LiveScan and he was transported to Jail.

Officers attempted to stop a male subject on a bicycle for vehicle code violations. The rider fled on his bike then on foot. Officers chased him on foot and by car. In the pursuit he discarded his jacket which contained **a loaded .32 semi-automatic handgun**. He was captured and found to be in possession of methamphetamine. He is on AB109 probation and is also a local gang member. He was transported to Jail.

Residents from the 600 block of I Street reported a hit and run which recently occurred. The suspect's front bumper and plate were left behind and a parked vehicle sustained major damage. The suspect's vehicle was left parked in gear on the street. An ID was left in the car for a person residing on I Street. Officers were able to enter the residence and locate the driver of the suspect vehicle. He was highly intoxicated and admitted to the collision and ownership of the car. He was arrested and transported to Jail.

Officers conducted a vehicle check at the pool park on Bass Ave. The driver was found to have two extraditable arrest warrants out of Santa Clara County. He was taken into custody and found to be in possession of cocaine. The vehicle was towed and stored. The suspect was transported to Jail.

A resident advised two males were trespassing on his property on Derrick Ave. The house is currently vacant and two males were located at the residence. The resident requested to file charges. Both subjects cited for trespassing.

An employee at the Mendota Elementary School reported a burglary to an exterior storage room that took place sometime overnight. Cleaning chemicals and various gardening tools were taken. No surveillance cameras are currently installed on the premises.

Officers stopped a black Mazda pickup at 9th and Oller St. for vehicle code violations. The driver was found to have outstanding arrest warrants. She was taken into custody, processed at MPD and then released on citation. The vehicle was towed and storage.

Officers responded to the southwest corner of 7th St. and Derrick St. for the report of shots fired with a subject down bleeding. Upon arrival officer found a male subject lying on the ground with multiple gunshot wounds. Officers performed CPR prior to EMS arrival. The victim later died while in route to the hospital. Witness to the incident were contacted and detained. The Fresno County Sheriff's Office Homicide team responded and is handling the investigation.

Officers were advised of a CHP unit pursuing a vehicle for failure to yield that was heading into Mendota. While in route to assist the CHP unit discontinued the pursuit. Later in the shift officers located the vehicle in the 700 block of Lolita (alley). The vehicle was a stolen out of Fresno. The vehicle was towed and stored.

A male subject was checked due to riding a bicycle in violation of the Vehicle Code. He gave officers multiple names and DOBs. He was eventually processes and his true identity was determined. He was cited for lying to police during the course of an investigation.

Search Warrant Service: Officers had received information regarding narcotic trafficking from a specific residence. Working as a team they concentrated efforts to obtain enough information for a search warrant. A warrant was secured and served at the location. Methamphetamine individually packaged for sales, transaction documents, a digital scale, currency and **a loaded/unregistered Springfield. 40-cal semi-automatic handgun** was seized. The suspected drug dealer was arrested and transported to Jail.

Officers conducted a subject check at 7th/Quince for riding a bicycle in violation of the Vehicle Code. A subsequent search produced a baggie of methamphetamine. The suspect was issued a citation and released.

A vehicle was stopped at 2nd Street / I Street for traffic violations. The driver was found to have two outstanding felony narcotic warrants and a misdemeanor warrant. He was later found to be in possession of methamphetamine and use paraphernalia. He was arrested and transported to Jail.

Officers conducted a subject check behind City Hall. The male subject claimed to be a former gang member who moved from Los Angeles. Photos and information was documented.

Officers assisted a Parole Agent in the arrest of a wanted parole violator. He was taken into custody without incident at his residence. He was violated due to not taking his medication and showing signs of violent tendencies. Parole wanted to remove him and have him restart his medication prior to any outward acts of violence. He was processed at the MPD and then transported to Jail.

Mendota High School personnel discovered missing equipment from the after school program. After an inventory they discovered small hand computers and cameras missing. Items were valued at over \$7,000.

Crime Analysis information revealed a stolen vehicle crime pattern has developed in Mendota. Some thefts are concentrated in the northern neighborhoods. Personnel have studied the information and are directing patrol efforts to combat the rise in vehicle thefts.

Officers stopped a male subject at Sorensen and Fleming for riding his bicycle in violation of the vehicle code. He was discovered to be on probation. A search located shotgun shells. He was arrested and cited per his probation officer.

Officers conducted a vehicle stop and discovered the driver had two outstanding arrest warrants. He was taken into custody and transported to Jail.

Officers responded to the Burger King regarding a drunk female causing a disturbance. She was found to be on probation for an alcohol related crime. She was arrested for probation violation per her probation officer and transported to Jail.

Officers conducted a subject check of a female at 5<sup>th</sup> and Lolita. A search discovered a baggie containing methamphetamine. She was arrested, cited and released to family.

Officers conducted a patrol check at an abandon apartment on Oller Street. Two subjects were located squatting in a vacant apartment. The structure had signage reading "No Trespassing". Narcotic paraphernalia was located in the subject's possessions. Both were arrested, cited and released.

Officers conducted a subject check on a female by city hall. Narcotic paraphernalia and prescription pills were located in her possession. She was arrested, cited and released.

Officers conducted a vehicle stop for speeding in a school zone. The driver was unlicensed and had an outstanding warrant for his arrest. A record check revealed he was a repeat offender for driving while unlicensed. His vehicle was stored and he was cited.

Officers responded to a call of a male and female fighting. Upon arriving they found a female with a stab wound and blood upon her clothing. The knife wound was superficial and EMS medically cleared her at the scene. A knife was recovered at the scene. The male was arrested and transported to Jail.

Officers were dispatched to an address regarding an unwanted subject. Upon arriving the subject agreed to leave, but then became uncooperative with officers. Upon noticing she exhibited signs of narcotic influence officers investigated her possibly being under the influence. Narcotic paraphernalia and possible cocaine was located. She was arrested and transported to Jail.

Upon contacting a suspicious person wearing a mask while riding a bicycle, officers located an illegal knife tucked into his waistband. He was arrested and transported to Jail.

Officers contacted two males who appeared to hide something next to parked cars as officers approached. Methamphetamine wrapped in a one dollar bill was found tucked under the vehicle tire. One of the subjects was arrested, cited and released.

Officers recognized a subject behind a building on Derrick as having an outstanding warrant. Upon contact the warrant was confirmed and the person was taken into custody and transported to Jail.

Officers made a vehicle check on an illegally parked vehicle on Lozano Street. Both occupants were found to be drinking and in possession of Cocaine. One also had an outstanding warrant for arrest. Both were arrested.

Officers responded to a report of a male subject enticing young girls with money and asking them to go with him. The male was contacted and subsequently arrested and transported to Jail.

Officers conducted a subject check on a male who was found to have an outstanding warrant for his arrest. He was arrested and transported to Jail.

Officers conducted a vehicle stop at Naples and 8<sup>th</sup>. The passenger was found to have a felony warrant for her arrest. She was arrested and transported to Jail.

Citizen reported finding a 3 yr old child walking alone on Black Street. Officers were able to discover the child left its home without the mother knowing. Family was reunited.

Officers conducted a subject check at Marie and 2<sup>nd</sup> street and discovered the person had an outstanding warrant for their arrest. He was arrested, cited and released.

A female reported she was inappropriately touched by a known male subject. The male was located by officers. During questioning he confessed to the crimes and was subsequently arrested and transported to Jail.

Officers conducted subject checks on two males at Rojas Park. Both were associated gang members with identifiable tattoos. Information was gathered on both.

Officers contacted three males at the Pool Park. All were associated with a local gang. Information was gathered on all.

City Hall staff reported a possible fraud attempt. An invoice totaling over \$12,000,000 was received by the City from a business in Bakersfield. Networking with Bakersfield PD, no information on the business was known. The investigation is ongoing.

Officers conducted a subject check at 9<sup>th</sup> and Oller. The male subject had two active warrants for his arrest. He was taken into custody, processed at MPD and released.

While on duty and in full uniform, officers witnessed a hand to hand marijuana transaction between two individuals. Both subjects were arrested and processed at MPD. Both were released on citations.

Officers conducted a subject check at Fourth and I Street. The male subject had two outstanding warrants for his arrest. He was arrested, processed at MPD and released on a citation.

Officers contacted a male subject at Lolita and Divisadero. He is on probation for auto theft and open to search and seizure. He was found to be in possession of Methamphetamine and arrested. Remarkably; there were no auto thefts during this shift.

Officers conducted a vehicle stop at Seventh and Stamoules. The driver was found to have an outstanding arrest warrant. He was arrested, processed at MPD and released on citation.

While on a patrol check of the Pool Park officers located a number of subjects associated with a local gang. Information was gathered on all. One subject was found to be in possession of a large knife and arrested. He was processed at MPD and transported to jail.

A male subject reported he was contacted at Sixth and Lolita by an unknown subject driving a black car. There were two females in the car at the time. The driver exited and pulled a knife on him. The subject demanded his wallet and then robbed him of it. All three fled the scene in the black car.

Officers conducted a subject check on a male and discovered he had an outstanding arrest warrant. He was eventually released on citation.

Officers were dispatched to a disturbance at a local store. No crime. Person causing was contacted and found to be affiliated with a Firebaugh gang. Information was obtained on him and he was released.

Officers conducted a subject check at 6<sup>th</sup> and Oller. The subject was found to have an active warrant for his arrest. He was arrested and transported to Jail.

Officers responded to the DMV/City Hall parking lot regarding a hit & run that had just occurred. Witness stated a two tone SUV which was parked next to her gray Toyota Corolla, struck her vehicle and left at a high rate of speed. Video was obtained from City Hall Security cameras. Based on the footage a female passenger from the suspect vehicle had gone into City Hall and paid a water bill. Officers went to the address on the water bill and located the suspect vehicle. The identified driver admitted being involved in the hit & run. He was arrested and transported to MPD for processing. He was later released with a citation.

Officers conducted a subject check on a male adult at 7<sup>th</sup> and Lolita. He was found to be a local gang member. Information was obtained on him.

### **Strategic Planning:**

I am continuing to Look, Listen and Learn and network with peer Police Chief's and allied agencies.

MPD has taken possession of the two new vehicles. The Expedition is replacing patrol vehicle #83. The Interceptor will replace detective vehicle #86. Patrol vehicle #81 will then be downgraded to a detective vehicle. Retired vehicles #83 and #86 both have high maintenance records and will then be sent to auction.

Cooks Communication will handle the up-fit of our new vehicles. Some parts are on backorder and will not arrive until May 21. Up-fit of the Explorer will not start until then.

The five new computers & monitors were installed in the PD and are operational.

Working on the 15/16 Budget and researching third party funding for personnel and equipment.

Met with MUSD Superintendent and administrative personnel regarding the proposed SRO for school year 15/16. We are moving forward to making this a reality.
