MINUTES OF MENDOTA REGULAR CITY COUNCIL MEETING

Regular MeetingSeptember 13, 2016

Meeting called to order by Mayor Silva at 6:01 p.m.

Roll Call

Council Members Present: Mayor Robert Silva, Mayor Pro Tem Sergio Valdez, Councilors Joseph Amador, Rolando Castro, and Joseph Riofrio.

Council Members Absent: None.

Flag salute led by Councilor Castro.

Invocation led by Raymond Acquino.

FINALIZE THE AGENDA

City Manager DiMaggio requested that the Council add a Business item regarding a request to utilize City property for a circus.

A motion was made by Councilor Riofrio to adopt the agenda as requested by staff, seconded by Mayor Pro Tem Valdez; unanimously approved (5 ayes).

PROCLAMATION

1. **Proclamation No. 16-03**: Declaring the month of September as Latino Voter Registration Month.

A motion was made to adopt Proclamation No. 16-03 by Councilor Riofrio, seconded by Councilor Amador; unanimously approved (5 ayes).

A motion was made by Councilor Amador to approve items 1 and 2, seconded by Councilor Riofrio; unanimously approved (5 ayes).

A motion was made to approve items 1 through 4 of the Consent Calendar by Councilor Riofrio, seconded by Councilor Amador; unanimously approved (5 ayes).

BUSINESS

1. Council consideration on issuing an Exclusive Use permit for a Circus on City owned property. [Added to the agenda]

Mayor Silva introduced the item and City Manager DiMaggio reported that he received a request to utilize City property on 7th and Riofrio Streets for a circus; various issues that have been discussed with the City Attorney regarding the issue; and the item being considered by Council due to the proposed event being held within 21 days.

Jonatan Walter (Walter Bros. Circus) – thanked the Council for considering the item and provided a description of the circus.

Discussion was held on the fees that Walter Bros. Circus needs to pay to the City and the possibility of transferring the revenue that is received to the Mendota Community Corporation (MCC).

A motion was made to approve the Facility Use Application, with the included conditions, and to transfer the revenue that is received to the MMC by Councilor Riofrio, seconded by Councilor Castro; unanimously approved (5 ayes).

 Proposed adoption of Ordinance No. 16-07: An ordinance amending the official zoning map of the City of Mendota to reflect a change of zone for a portion of Assessor's Parcel Number 013-141-02S from M-1 Light Manufacturing to M-2 Heavy Manufacturing, and give second reading, by title only, with further reading waived.

Mayor Silva introduced the item and Planning & Public Works Director Gonzalez summarized the report.

A motion was made to adopt Ordinance No. 16-07 by Councilor Riofrio, seconded by Mayor Pro Tem Valdez; unanimously approved (5 ayes).

3. Council discussion and proposed action on the formation of a Police Officer Compensation Subcommittee.

Mayor Silva introduced the item and City Manager DiMaggio summarized the report including that Mendota Police Department salaries are falling behind the peer group; the need to study the issue to analyze the salaries for other communities; the effects that the minimum wage increase will have on salaries; and the duties of the proposed subcommittee.

Discussion was held on the history of the reestablishment of the Mendota Police Department; the dedication of the police officers to serve the community; the effects of high officer turnover; the possibility of expediting the study of the subcommittee; and whether a subcommittee is needed to study police officer salaries.

Oscar Rivas (Mendota Police Officers Association [MPOA]) – introduced himself as the MPOA president; stated that he cares about Mendota and wants to continue being an officer in Mendota; requested that the officers be paid fair salaries; and thanked Council for their positive comments regarding the officers.

Councilor Castro stated that the subcommittee will move forward in studying police officer salaries.

Mayor Silva requested that Councilor Castro be appointed as the Chairperson of the

subcommittee.

A motion was made to appoint Councilor Castro, as Chairperson, and Councilor Amador to the subcommittee by Councilor Riofrio, seconded by Mayor Pro Tem Valdez; unanimously approved (5 ayes).

PUBLIC HEARING

1. Proposed adoption of **Resolution No. 16-59**, adopting Tentative Parcel Map No. 16-02.

Mayor Silva introduced the item and Planning & Public Works Director Gonzalez sumarized the report including that the City entered into a settlement agreement earlier this year regarding the Warkentine and Tankersley properties; the various conditions contained within the settlement agreement; and shared staff's recommendation.

At 6:35 p.m. Mayor Silva opened the hearing to the public and, seeing no one present wishing to comment, closed it in that same minute.

A motion was made to adopt Resolution No. 16-59 by Councilor Riofrio, seconded by Mayor Pro Tem Valdez; approved (5 ayes).

2. Proposed adoption of **Resolution No. 16-62**, authorizing staff to submit a Community Development Block Grant for the Fiscal Year of 2017-2018.

Mayor Silva introduced the item and City Manager summarized the report including that funding that is being requested for the fiscal year 2017-2018; designating certain CDBG funds for improvements to Rojas-Pierce Park; and the inability of utilizing development impact fees from the Las Palmas development to fund Rojas-Pierce Park improvements; and other possible funding options that the City has.

At 6:42 p.m. Mayor Silva opened the hearing to the public.

Kevin Romero (160 Tuft Street) - inquired on how the change of funding will affect the timeline of the project and inquired on whether further expansions will occur.

At 6:45 p.m. Mayor Silva closed the hearing to the public.

A motion was made to adopt Resolution No. 16-62 by Mayor Pro Tem Valdez, seconded by Councilor Riofrio; unanimously approved (5 ayes).

3. Introduction of **Ordinance No. 16-08**: An ordinance adopting the Official Plan Line for portions of Smoot Avenue and Amador Street, and give first reading, by title only, with second reading waived.

Mayor Silva introduced the item and City Manager DiMaggio reported that item provides

a layout of the Official Plot Line for the extension of Smoot Avenue and Amador Street; stated that the City does not own a portion of the land in which the streets will be expanded to; and that the purpose of the ordinance is to affirm that the City intends to implement its General Plan.

Discussion was held on the possibility of Westlands Water District donating the land to the City and where the separation between City property and Westlands property is.

At 6:52 p.m. Mayor Silva opened the hearing to the public and, seeing no one present wishing to comment, closed it in that same minute.

A motion was made to perform the first reading of Ordinance No. 16-08, with the second reading waived, by Councilor Riofrio, seconded by Mayor Pro Tem Valdez; unanimously approved (5 ayes).

DEPARTMENT REPORTS AND INFORMATIONAL ITEMS

1. Code Enforcement a) Monthly Report

Economic Development Manager Flood summarized the report including the officer's focus for the month of August being water conservation regulations and business licenses; placing code enforcement fines on utility bills to ensure payment; and ways that the public can report a violation.

Discussion was held on a yard sale that is held every Sunday on 7th Street; the deadline for businesses to submit business license paperwork; and abandoned shopping carts throughout the City.

2. Police Department a) Monthly Report

Chief of Police Andreotti reported on a group of people that are stealing purses; staff transporting vehicles to the Avenal prison to be re-painted; and implementing an Explorer Program at Mendota High School.

Discussion was held on whether Rojas-Pierce Park's restrooms are secured at night and whether it is possible to paint Code Enforcement's vehicles.

3. City Attorney

City Attorney Kinsey reported that the City will be changing the way it handles claims.

Discussion was held on the procedures the City will follow in regards to claims and whether single-family homes need to have active utility services if individuals are living in the homes.

City Manager DiMaggio reported that the Fresno County Board of Supervisors would honor the canal rescue individuals at their September 27th meeting; a conversation he had with Superintendent Lopez regarding holding a City Council/Joint School Board early October; and the status of the BB Bridge investigation.

Discussion was held on rescheduling the proposed Joint City Council/School Board meeting.

Discussion was held on honoring boxer Enrique Noyola and Nathan Rosales at the next City Council meeting.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA TO TAX DEFER MEMBER PAID CONTRIBUTIONS TO CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM

WHEREAS, the City of Mendota has the authority to implement the provisions of section 414(h)(2) of the Internal Revenue Code (IRC); and

WHEREAS, the City of Mendota has determined that even though the implementation of provisions of section 414(h)(2) IRC is not required by law, the tax benefit offered by section 414(h)(2) IRC should be provided to all employees recognized in the Miscellaneous Class of employment who are members of the California Public Employees' Retirement System:

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mendota as follows:

- I. That the City will implement the provision of section 414(h)(2) IRC by making employee contributions pursuant to California Government Code Section 20691 to the California Public Employees' Retirement System of behalf of all its employees in a recognized class of employment who are members of the California Public Employees Retirement System. "Employee contributions" shall mean those contributions to the Public Employees' Retirement System which are deducted from the salary of employees and are credited to individual employee's accounts pursuant to California Government Code Section 20691.
- II. That the contribution made by the City of Mendota to the California Public Employees' Retirement System, although designated as employee contributions, are being paid by the City of Mendota in lieu of contributions by the employees who are members of the California Public Employees' Retirement System.
- III. That employees of the City of Mendota shall not have the option of choosing to receive the contributed amounts directly instead of having them paid by the City of Mendota to the California Public Employees' Retirement System.
- IV. That the City of Mendota shall pay to the California Public Employees' Retirement System the contribution designated as employee contributions from the same source of funds as used in paying salary.

- V. That the amount of the contributions designated as employee contributions and paid by the City of Mendota to the California Public Employees' Retirement System on behalf of an employee shall be the entire contribution required of the employee by the California Public Employees' Retirement Law (California Government Code Sections 20000, et seq.).
- VI. That the contributions designated as employee contributions made by the City of Mendota to the California Public Employees' Retirement System shall be treated for all purposes, other than taxation, in the same way that member contributions are treated by the California Public Employees' Retirement System.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA TO APPROVE THE TAX DEFERRED DEDUCTION PLAN FOR SERVICE CREDIT PURCHASES

WHEREAS, the Board of Administration of the California Public Employees' Retirement System at the April 1996 meeting approved a Tax-Deferred payroll deduction plan for service credit purchases under Internal Revenue Code (IRC) section 414(h)(2); and

WHEREAS, the City of Mendota has the authority to implement the provisions of IRC section 414(h)(2) and has determined that even though implementation is not required by law, the tax benefit offered by this section should be provided to those employees who are members of the California Public Employees' Retirement System; and

WHEREAS, the City of Mendota elects to participate in the Tax-Deferred payroll deduction plan for all employees in the following California Public Employees' Retirement System employee classification:

Miscellaneous Class

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mendota as follows:

- I. That the City will implement the provision of section 414(h)(2) IRC by making employee contributions for service credit purchases pursuant to the California State Government Code on behalf of its employees who are members of the California Public Employees' Retirement System and who have made a binding irrevocable election to participate in the Tax-Deferred payroll deduction plan. "Employee contributions" shall mean those contributions reported to the California Public Employees' Retirement System which are deducted from the salary of employees and are credited to individual employee accounts for service credit purchases, thereby resulting in tax deferral of employee contributions.
- II. That the contribution made by the City of Mendota to the California Public Employees' Retirement System, although designated as employee contributions, are being paid by the City of Mendota in lieu of contributions by the employees who are members of the California Public Employees' Retirement System.

- III. That employees of the City of Mendota shall not have the option of choosing to receive the contributed amounts directly instead of having them paid by the City of Mendota to the California Public Employees' Retirement System.
- IV. That the City of Mendota shall pay to the California Public Employees' Retirement System the contribution designated as employee contributions from the same source of funds as used in paying salary, thereby resulting in tax deferral of employee contributions.
- V. That the effective date for commencement of the Tax-Deferred payroll deduction plan cannot be any earlier than the date the completed resolution is received and approved by the California Public Employees' Retirement System.
- VI. That the governing body of the City of Mendota shall participate in and adhere to requirements and restrictions of the Tax-Deferred payroll deduction plan by reporting Tax-Deferred payroll deductions when authorized by the California Public Employees' Retirement System for those employees of the above stated employee classification who have elected to participate in this plan.

ORDINANCE NO. 16-08

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MENDOTA, CALIFORNIA, ADOPTING THE OFFICIAL PLAN LINE FOR PORTIONS OF SMOOT AVENUE AND AMADOR STREET

WHEREAS, City Staff has initiated a recommendation for the adoption of an Official Plan Line (OPL) for planned street segments for (1) Smoot Avenue from approximately Gregg Court West to the Amador Street alignment and (2) Amador Street from approximately the Homes Avenue alignment to Belmont Avenue (the "Smoot/Amador OPL"; and

WHEREAS, the roadway segments contemplated under the Smoot/Amador OPL were contemplated under the Circulation Element of the City's 2009 General Plan Update 2005-2025 (the "General Plan"); and

WHEREAS, in connection with the City's approval of the General Plan, the City circulated an Environmental Impact Report, State Clearinghouse Number 2007011083 (the "EIR"), to address the potential environmental impacts associated with the General Plan under the California Environmental Quality Act, Pub. Resources Code, § 21000, *et seq.* ("CEQA"); and

WHEREAS, none of the circumstances or conditions specified in Section 15162 of CEQA Guidelines have occurred, and therefore a subsequent or supplemental environmental impact report is not required for the Smoot/Amador OPL.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MENDOTA, CALIFORNIA, DOES HEREBY ORDAIN AS FOLLOWS:

1. Based upon the testimony and information presented to the City of Mendota, and upon review and consideration of the environmental documentation provided, the adoption of the proposed Smoot/Amador OPL is in the best interest of the City of Mendota. The City Council finds in accordance with its own independent judgment that there is no substantial evidence in the record that the adoption of the proposed Smoot/Amador OPL may have additional significant effects on the environment that were not identified in the EIR, and that no new additional mitigation measures or alternatives may be required. In addition, the City Council finds that no substantial changes have occurred with respect to the circumstances under which the EIR was certified, and that no new information, which was not known and could not have been known at the time the EIR was certified as complete, has become available. Accordingly, the City Council finds that a subsequent or supplemental environmental impact report is not required.

2. The City Council finds the map presented to the City Council concurrently with this ordinance and on file with the City's Public Works Department, entitled "Official Plan Lines: Amador Street North of Belmont Avenue and Smoot Avenue West of Sorensen Avenue," a copy of which is attached as Exhibit "A," is hereby adopted and made part of the Official Plan Line of streets and highways for street use and filed with the City's Public Works Department.

3. This ordinance shall become effective and in full force at 12:00 midnight on the 31st day following its adoption.







STREETS AND ROADS

- Street sweeping continues as usual.
- Crews repaired a concrete approach on 10th street. The concrete was damaged due to a hydrant lateral break.
- Crews trimmed trees on Oller and 7th Street right of ways. Empty tree wells will get replacement trees once the weather becomes more favorable.
- Stop sign and striping was installed at the intersection of Holmes and Sorensen Streets.
- Road end barricades were installed at Holmes and Sorensen Streets dead-ends.
- Crews will begin replacing damaged pavement at all water leak locations.
- The sections of Marie and Divisadero Streets that will be reconstructed have been designed. The bid opening for this project is on 10/18/2016.

PARKS AND PUBLIC BUILDINGS

- Public Works continues to maintain the parks for the community.
- Restrooms at Rojas Park will be locked during night hours to prevent graffiti, vandalism and illegal activity that has been taking place.
- A water leak was repaired at Veterans Park. There was a leak at the "T" fitting that feeds the entire park. Street repairs and some concrete work will follow.
- Contract work was performed at the City owned DMV building at the request of DMV. This included labor and material to install a "Dutch" style door. The cost of this work will be reimbursed by DMV.

• Fencing with privacy slats have been installed at City Hall to secure alternative fuel vehicles.

DRINKING WATER

- Water usage has increased this month 3% compared to last year. We are required to save 25% of water compared to 2013 calendar year.
- Bids for the water plant structure project came in extremely over bid. The project will not go into construction at this time. The plans and specs can be re-used in the future if funding and the level of priority merit construction.
- Meter reads are complete.
- The water treatment's SCADA system is being upgraded. This will help avoid glitches in communication between wells, booster pumps and the filter systems. Work and progress continue on this capital improvement item.
- Fire hydrant located in the alley on 10th Street between Oller and Naples Streets got replaced. Concrete flat work was also replaced surrounding the hydrant.
- City water obligations have been, met per the drinking water agreement with the private land owner where City wells are currently located.

WASTE WATER

- Engineering plans and specifications for the upgrade to the Lozano lift station are complete. Bid opening is tentatively set for October 14th at 2:30 PM. This is a capital improvement plan project approved in the 2016-2017 Fiscal Year Budget.
- Monthly samples have been submitted.
- Pump #3 at the waste water lift station has been replaced and is back on line.
- Aerator maintenance continues.
