Meggin Boranian, Assistant City Attorney, provided training that covered ethics topics as required by Article 2.4 of Chapter 2 of Part 1 of Division 2 of Title 5 of the Government Code which include laws relating to personal financial gain by public servants, perquisites ("perks") of office, prohibitions against the use of public resources for personal or political purposes, prohibitions against gifts of public funds, and prohibitions against acceptance of free or discounted transportation, government transparency laws,
