Special Meeting Monday, March 15, 2016 6:30 p.m.

Meeting called to order by Chairperson Luna at 6:30 PM.

A motion was made by Commissioner Escobedo to adopt the agenda, seconded by Vice-Chairperson Quintanar; unanimously approved (4 ayes, absent: Garcia).

MINUTES AND NOTICE OF WAIVING OF READING

A motion to approve items 1 and 2 was made by Commissioner Escobedo, seconded by Vice-Chairperson Quintanar; unanimously approved (4 ayes, absent: Garcia).

PUBLIC HEARING

1. Proposed Adoption of **Resolution No. PC 16-02**: Recommending that the City Council of the City of Mendota Adopt an Ordinance Amending Chapter 8.36 of the Mendota Municipal Code Relating to the Establishment and Operation of Medical Marijuana Dispensaries, the Indoor and Outdoor Cultivation of Medical Marijuana, and the Delivery of Medical Marijuana.

Chairperson Luna introduced the item and City Attorney Kinsey introduced himself to the Planning Commission and summarized the report including that the Medical Marijuana Regulation and Safety Act provides a statewide program for the licensing and regulation of commercial cannabis activity; the extended deadline for local governments to either issue regulations in regards to medical marijuana businesses or to prohibit such operations; the resolution of intent that Council adopted which aims towards the prohibition of the establishment and operation of medical marijuana businesses within the City (6:37 p.m. Commissioner Espinoza entered the Council Chambers); and the proposed ordinance that staff created regarding the prohibition of the establishment and operation of medical marijuana businesses within the City.

Discussion was held on whether individuals who currently possess medical marijuana cards will be in violation of the ordinance; Council's ability to limit the use of medical marijuana within City limits; ways to enforce the ordinance; and the prohibition of cultivation of medical marijuana within the City.

At 6:40 p.m. Chairperson Luna opened the hearing to the public.

John Flores (615 J Street) – explained that he supports the proposed ordinance; concerns regarding Coalinga's position on the issue; and the importance of not relying on medical marijuana to bring better economic opportunities to the City.

Discussion was held on the different positions that cities are taking in regards to the issue; the benefits of allowing medical marijuana dispensaries in the City; the negative impact that drugs has on the community; medical marijuana being illegal under federal law; and safety concerns that arise regarding medical marijuana businesses.

At 6:56 p.m. Chairperson Luna closed the hearing to the public.

A motion was made to adopt Resolution No. PC 16-02 by Vice-Chairperson Quintanar, seconded by Commissioner Escobedo; unanimously approved (5 ayes, absent: Garcia).

SUBJECT: Consideration and proposed action on a resolution recommending that the City

Council of the City of Mendota Adopt an Amendment to the City of Mendota General Plan, Modify the Land Use Designation and City Zoning Map Relating to the Properties Identified as Fresno County Assessor's Parcel Nos. 013-141-02S

and 013-152-27S.

RECOMMENDATION:

Continue the hearing on the Planning Commission's proposed recommendation that the City Council of the City of Mendota Adopt an Amendment to the City of Mendota General Plan, Modify the Land Use Designation and City Zoning Map Relating to the Properties Identified as Fresno County Assessor's Parcel Nos. 013-141-02S and 013-152-27S, to the June 21, 2016, regular Planning Commission meeting.

BACKGROUND:

In February 2016, the City entered into a settlement agreement, which contains provisions contemplating the re-zoning of two properties identified as Assessor's Parcel Numbers 013-141-02S and 013-152-27S (collectively, the "Subject Properties") from M-1 (Light Manufacturing) to M-2 (Heavy Manufacturing).

To effectuate the rezoning, the City would need to consider an amendment to the City's existing General Plan, as well as other approvals.

At its March 22, 2016, meeting, the City Council adopted a resolution declaring its intention (the "Resolution of Intention") to, *inter alia*, propose amendments to the City's General Plan to accommodate the rezoning and other approvals, and requesting that the Secretary schedule a public hearing before the Planning Commission on those issues.

DISCUSSION:

The City's Municipal Code requires the Planning Commission to conduct a public hearing on the General Plan Amendment and rezoning of the property no less than ten (10) days nor more than forty (40) days after the City Council's adoption of the Resolution of Intention. However, in order for the Planning Commission to meets its obligations under the California Environmental Quality Act, Pub. Resources Code, § 21000, *et seq.* ("CEQA"), the City must first consider the potential environmental effects if the proposed approvals.

City staff anticipates that it will complete the environmental review process under CEQA for the proposed approvals within approximately 45 days. As such, City staff requests that the Planning Commission continue the hearing on the rezoning, the General Plan Amendment, and the related approvals to the Planning Commission's June 21, 2016, meeting.
