# APPROVAL OF MINUTES AND NOTICE OF WAIVING READING

A motion was made by Vice-Chairperson Ochoa to approve item 1, seconded by Commissioner Romero; unanimously approved (5 ayes, absent: Barron and Gonzalez).

A motion was made by Vice-Chairperson Ochoa to approve item 2, seconded by Commissioner Alonso; unanimously approved (5 ayes, absent: Barron and Gonzalez).

# **BUSINESS**

1. Commission discussion and action on the submitted requests for exclusive use of City Facilities for recreation purposes.

Chairperson Mendoza introduced the item and City Clerk Cabrera-Garcia summarized the report including the applications that were received, and staff's recommendation.

Discussion was held on the schedule for both organizations for last year.

**Salvador Ochoa** – commented on how the schedule was made in 2019.

Discussion was held on the days that are being requested by both organizations.

**Salvador Ochoa** – provided information on the Mendota Baseball League's (MBL) program.

Discussion was held on the amount of games that each organization will have, and the amount of time that they will need to prepare and clean-up.

**Jesus Martinez** – stated that MBL had issues with the baseball pads and pegs last year.

Discussion was held on which length baseball pads were used.

**Irene Barajas** – stated that last year Mendota Youth Baseball (MYB) accommodated the schedule of MBL; and provided information on the tournaments that MYB hosts.

Discussion was held on the proposed schedule for both organizations; the number of participants that both leagues have; and the flexibility of the schedules of both organizations.

**Sergio Valdez** – provided information on how the Cal Ripken league functions; and the need for MYB to be able to use the field on Saturdays.

Discussion was held on alternating the use of the field on Saturdays; the condition of the field; and City staff evaluating the condition of the field before each use.

A motion was made by Vice-Chairperson Ochoa to approve the applications with the following schedule and conditions of approval, seconded by Commissioner Alonso; unanimously approved (4 ayes, abstain: Romero, absent: Barron and Gonzalez).

Shall a conflict arise in coordinating the use of the field by both organizations on a Saturday by, the City of Mendota will work with both organizations to reach an alternate decision.

- Tuesdays and Thursdays: 4:00 p.m. 9:00 p.m.
- Saturdays: To Be Determined
  - Once a schedule is created, Mendota Youth Recreation (MYR) will submit the schedule to Westside Youth Inc. (WSY) and the City of Mendota. MYR will coordinate with WSY to determine MYR's use of the field on Saturdays. Shall a conflict arise regarding coordinating the use of the field by both organizations on a Saturday, the City of Mendota will work with both organizations to reach an alternate decision.

Both organizations shall:

- Provide Current Proof of Liability Insurance.
- Receive the keys on the specified dates set and shall not make copies of the keys.
- Provide the City with any updates to its schedule, including any changes that cause the field to be unused when it was previously declared to be used.
- Maintain the field and other property based on their use and immediately report any observed problems, whether or not caused directly by their use, to City Hall.

# COMMISSIONER REPORTS AND INFORMATIONAL ITEMS

Chairperson Mendoza inquired about potential sponsorship opportunities for the new baseball field.

Commissioner Urias inquired about the possibility of replacing the basketball nets at Rojas-Pierce Park.

Discussion was held on individuals playing soccer on the basketball courts at Rojas-Pierce Park; lighting issues at the kid's play area pat Rojas-Pierce Park; the status of the Community Center; and the upcoming Earth Day event.
