SUBJECT: APPLICATION FOR USE OF THE BASEBALL FIELD BY THE MENDOTA BOYS &

GIRLS CLUB FOR FLAG FOOTBALL PRACTICES AND GAMES

DATE: JANUARY 4, 2018

ISSUE

Shall the Commission approve an Exclusive Use Permit from the Mendota Boys & Girls Club to use the Benny Mares Sr. Baseball Field (the Field) and open grass area north of the skate park for flag football practices and games?

BACKGROUND

Staff received a request from the Mendota Boys & Girls Club (the Club) to use the baseball field for flag football practices and games. The schedule is included with this report and requests the use on Monday, Wednesdays, and Fridays from 4pm to 7pm January 18, 2018 to March 2, 2018. They would also use the concession stand on Fridays when they hold their games. The participants in the league are 4th through 8th grade students.

Although the application does not state such, it is assumed that the use of the lights is also requested.

ANALYSIS

Since the renovation of the Field, the City Council has expressed its intent to protect it and limit its use to baseball/softball related activities. The forerunner to the Recreation Commission (the Baseball Commission) was created for the express intent of carrying out this duty, which remains with the Recreation Commission to the present. This body has recently communicated its desire and intent to limit the type of activity that goes on at the requested facility so as to preserve its condition as much as possible.

During these colder, wetter months it is especially vital to keep cleats off of the grass due to the elevated moisture, making it more susceptible to damage. Since this league is permitting youth up to 8th grade to participate, the damage caused by those larger youth wearing cleats can be similar to the wear an adult playing football would cause. Additionally, during a time when the City is implementing austere measures in order to safeguard the budget, the operation of the field and lights with minimum compensation (which is what would be afforded to a local youth non-profit according to the fee schedule) creates a cost to the General Fund that should be avoided.

Concerning a recommendation, staff sees the benefit of allowing youth to use the baseball field but recommends a denial of the application due to the other options that are at the disposal of the requesting organization (such as the use of facilities maintained by the school district, or waiting a month to start the league so as to take advantage of the sun setting later) and the increased wear (and cost) due to an activity the field is not intended for during a season in which it is not intended to be used.

FISCAL IMPACT

None.

RECOMMENDATION

Staff recommends that the Commission discuss the issues related to the use and deny the application.
