# MINUTES MENDOTA PUBLIC SAFETY SUB-COMMITTEE MEETING October 5, 2020 12:00 NOON Mendota City Hall

#### I. CALL TO ORDER

The meeting was called to order by Chairperson Martinez at 12:02 p.m.

#### **II. ADOPTION OF MINUTES**

The minutes for the meeting of August 3, 2020 were approved based on a motion made and seconded, and unanimous approval.

#### III. BUSINESS

- 1. Chairperson Martinez
  - a) COVID-19 Status

Chairperson Martinez introduced the item and provided information on the status of COVID-19 in the community.

b) Community Lighting Project
