MINUTES OF MENDOTA REGULAR RECREATION COMMISSION MEETING

Regular Meeting Thursday, September 6, 2018

Meeting called to order by Chairperson Robert Silva at 12:03 p.m.

Roll Call

Commissioners Present: Chairperson Robert Silva, Vice-Chairperson Paul

Ochoa, Commissioners Jessica Barron, Angela

Gonzalez, and John Sanchez.

Commissioners Absent: Commissioner Juan Luna

Flag Salute led by Chairperson Silva.

FINALIZE THE AGENDA

1. Adjustments to Agenda.

2. Adoption of final Agenda.

A motion was made by Commissioner Sanchez to adopt the agenda, seconded by Vice-Chairperson Ochoa; unanimously approved (5 ayes, absent: Luna).

CITIZENS ORAL AND WRITTEN PRESENTATIONS

None offered.

APPROVAL OF MINUTES AND NOTICE OF WAIVING READING

- 1. Approval of the minutes of the regular meeting of August 2, 2018.
- 2. Notice of waiving the reading of all resolutions introduced and/or adopted under this agenda.

A motion was made by Commissioner Sanchez to approve items 1 and 2, seconded by Vice-Chairperson Ochoa; unanimously approved (5 ayes, absent: Luna).

BUSINESS

1. Commission consider a request of Mendota Youth Recreation to use the baseball field for an adult softball tournament.

Chairperson Silva introduced the item and Economic Development Manager Flood summarized the report including that Mendota Youth Recreation (MYR) requested the use of the baseball field for an adult softball tournament every Monday through November; that the purpose of the tournament was to raise funds for "girls basketball"; that the City Council and the Recreation Commission have in the past given priority use to youth organizations; the fees that need to be paid prior to the use of the field; that staff has no recommendation and was neutral on the application; and requested that the Commission discuss the application.

Discussion was held on whether the fees being charged are per day or for the entire duration of the league; which "girls basketball" team the tournament was fundraising for; whether there is a revenue agreement between MYR and the tournament's participants; whether the applicant would be attending the meeting; and the action that the Commission would be taking.

Chairperson Silva called Sergio Valdez of Mendota Youth Recreation to receive information about the application.

Discussion was held on whether the high school had been informed about the proposed fundraiser

Sergio Valdez (via phone call) – stated that MYR would inform the high school about the proposed fundraiser after the Commission considered the application.

Discussion was held on the amount of teams that will be participating in the tournament; the possibility of modifying the game days should another organization request the use of the field on a Monday; and whether the item in question is related to an item that was discussed at a previous Recreation Commission meeting.

A motion was made by Vice-Chairperson Ochoa to approve the application, with the condition that the appropriate fees be paid, seconded by Commissioner Sanchez; unanimously approved (5 ayes, absent: Luna).

Sergio Valdez (via phone call) – apologized for not being able to attend the meeting in person. *Phone call ended.*

Discussion was held on the circumstances surrounding fundraisers that involve the schools; informing the school first prior to submitting a facility-use application; and ensuring that the appropriate procedures are followed.

COMMISSIONER REPORTS AND INFORMATIONAL ITEMS

Chairperson Silva commented on the specifications and condition of the baseball field at McCabe Elementary.

Discussion was held on who utilizes the field; how the City can work with the Mendota Unified School District to make the field compliant with the required specifications for the 12 and under league; the Commission making a recommendation to the City Council to develop a baseball field at the empty lot near Rojas-Pierce Park; whether the La Colonia project will have a park component; the Mendota Police Officers Association holding a movie night event in the future; and the feedback that was received regarding the Mendota Fireworks Show.

ADJOURNMENT

At the hour of 12:32 p.m., with no more business to be brought before the Commission, a motion for adjournment was made by Commissioner Sanchez, with a second by Commissioner Barron; unanimously approved (5 ayes, absent: Luna).
