**I. CALL TO ORDER**

1. Chairperson Silva

a) Recent fires on empty lots with tall weeds

## 3. Code Enforcement

Economic Development Manager Flood provided an update on the weed abatement process, and stated that the code enforcement officers would be heavily enforcing water conservation measures during the summer.

Discussion was held on the status of significant cases.

## 4. Police Department

Police Chief Andreotti provided a personnel update; reported on the upcoming competition that the Explorer Program would be attending; and shared statistical information.

## 5. Other Business

Sonia Herrera with RCS-Fresno provided an update on the work.


Chuck Mosley with CHP – Los Banos provided a personnel update.
