

Chairperson Silva introduced the item and Assistant City Engineer Osborn reported on the adjustments made to the proposed site plan for the Rojas-Pierce Park Improvement Project based on the Commission's previous comments.

Discussion was held on installing shaded bleachers near the new fields; the issues surrounding installing an announcer's booth; the logistics for the wiring for the score board control box; installing secured wireless speakers; acquiring score boards for the new fields; installing a concession stand and restrooms near the soccer field; and installing trees behind the fields.

Commission consensus was reached to direct staff to make the necessary changes to the proposed site plan per the discussion.
